Specification 1: In that Sergeant Jose L. Brito, United States Marine Corps, on active duty, did, at or near Costa Mesa, California, on divers occasions, from on or about October 2008 to about December 2008, violate a lawful general order, to wit: Depot Order P1100.4B dated 1 September 2004, by wrongfully engaging in a nonprofessional relationship with Ms. Alicia Clanton, a prospective recruit applicant.

Specification 2: In that Sergeant Jose L. Brito, United States Marine Corps, on active duty, did, at or near Orange County, California, from on or about January 2008 to on or about May 2008, violate a lawful general order, to wit: Depot Order P1100.4B dated 1 September 2004, by wrongfully engaging in a nonprofessional relationship with Ms. Brittany Reaves, a prospective recruit applicant.

Specification 3: In that Sergeant Jose L. Brito, United States Marine Corps, on active duty, did, at or near Costa Mesa, California, on divers occasions, from on or about October 2008 to about December 2008, violate a lawful general order, to wit: Paragraph 4(g), Marine Corps Order 1700.22E, dated 21 March 2006, by wrongfully providing alcohol to Ms. Alicia Clanton, a prospective recruit applicant.

Specification 4: In that Sergeant Jose L. Brito, United States Marine Corps, on active duty, did, at or near Orange County, California, from on or about 1 May 2008 to on or about 31 May 2008, violate a lawful general order, to wit: Paragraph 4(g), Marine Corps Order 1700.22E, dated 21 March 2006, by wrongfully providing alcohol to Ms. Brittany Reaves, a prospective recruit applicant.

CHARGE II: VIOLATION OF THE UCMJ, ARTICLE 107

Specification 1: In that Sergeant Jose L. Brito, United States Marine Corps, on active duty, did, at or near Santa Ana, California, on or about 18 December 2008, with the intent to deceive, make to Captain Christopher Siekman, United States Marine Corps, an official statement, to wit: When asked how Ms. Alicia Clanton ended up at the Marine Corps Ball in November 2008 with Staff Sergeant Mark K. Mattson, United States Marine Corps, "We were all shocked to see her there, but I guess she met Staff Sergeant Mattson about a year ago or so, plus or minus, at a bar. I have no idea what establishment or what city," and "I saw her and I was shocked. I then asked SSgt Mattson and he said that he met her a year ago. Ms. Clanton was also shocked to see us," which statements were totally false, and were then known by the said Sergeant Jose L. Brito, to be so false.

Specification 2: In that Sergeant Jose L. Brito, United States Marine Corps, on active duty, did, at or near Santa Ana, California, on or about 18 December 2008, with the intent to deceive, make to Captain Christopher Siekman, United States Marine Corps, an official statement, to wit: When asked how Ms. Alicia Clanton met Staff Sergeant Mark K. Mattson, United States Marine Corps, "I was having dinner with Ms. Clanton at Ichi Biri in San Clemente. I was there with her alone until Mattson showed up," which statement was totally false, and was then known by the said Sergeant Jose L. Brito, to be so false.

CHARGE III: VIOLATION OF THE UCMJ, ARTICLE 120

Specification: In that Sergeant Jose L. Brito, United States Marine Corps, on active duty, did, at or near Orange County, California, on or about 1 May 2008 to on or about 31 May 2008, cause Ms. Brittany Reaves to engage in a sexual act, to wit: sexual intercourse, by using strength sufficient that she could not avoid or escape the sexual conduct.

CHARGE IV: VIOLATION OF THE UCMJ, ARTICLE 134

Specification 1: In that Sergeant Jose L. Brito, United States Marine Corps, on active duty, a married man, did, on divers occasions, at or near Costa Mesa, California, between on or about October 2008 to December 2008, wrongfully have sexual intercourse with Ms. Alicia Clanton, a woman not his wife.

Specification 2: In that Sergeant Jose L. Brito, United States Marine Corps, on active duty, a married man, did, at or near Orange County, California, between on or about 1 May 2008 to on or about 31 May 2008, wrongfully have sexual intercourse with Ms. Brittany Reaves, a woman not his wife.

Specification 3: In that Sergeant Jose L. Brito, United States Marine Corps, on active duty, did, at or near Costa Mesa, California, from on or about 1 December 2008 to on or about 31 December 2008, wrongfully endeavored to impede an investigation by communicating to Ms. Alicia Clanton, a potential witness in an official investigation, to not return telephone calls to Capt Christopher Siekman, United States Marines Corps, the investigating officer, and that if she did, it would hurt her chances of joining the Marine Corps.

Specification 4: In that Sergeant Jose L. Brito, United States Marine Corps, on active duty, did, at or near San Clemente, California, from on or about 1 December 2008 to on or about 31 December 2008, wrongfully endeavored to impede an investigation by communicating to Staff Sergeant Mark K. Mattson, United States Marine Corps, a witness in an official investigation, to communicate to Captain Christopher Siekman, United States Marine Corps, the investigating officer, that he, SSgt Mattson, met Ms. Alicia Clanton about a year ago at a bar in Huntington Beach and that he had not talked to her in the last year.
