<p>9. <i>SPC Schwager, David</i> , WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH:</p> <p>During the period of time I worked in the main office of finance at the front desk of the Milpay section at FOB Salerno, I regularly witnessed flirtatious behavior between 1LT Chow, Patricia and SFC Richard Jenkins. This behavior ranged from 1LT Chow sitting on SFC Jenkins lap to giggling at things he said, I witnessed on multiple occasion 1LT Chow being pulled onto SFC Jenkins lap where she would then sit, without being held or restrained, and she would continue to converse with the other personnel in the office and never appeared agitated or uncomfortable. She would sit on his lap without any sort of change in her demeanor. There were also times when SFC Jenkins would make a sexual comment directed at 1LT Chow. These were always said in a humorous manner and never maliciously, threateningly or with any sort of negative connotation. These comments were made in front of multiple personnel. When these comments were made, 1LT Chow would either giggle, stare at him oddly or say in a joking manner "you're crazy."</p>

She never appeared to have issue with the things SFC Jenkins said. ~~When~~ These were also times he might say something and she would lightly slap him on the arm and giggle in a very friendly and flirtatious manner. There were multiple times I saw 1LT Chow and SFC Jenkins go to dinner together. There were also times SFC Jenkins would request 1LT Chow go out back of the finance office with just him. She would always accompany him out back with a smile. 1LT Chow would regularly come into our section (mil-pay) of the office and sit either by the digital sender or stand near SFC Jenkins. She never appeared to have any sort of personal issue with SFC Jenkins. It was a common office joke that they had some sort of weird relationship because of their flirting. This behavior had been the same between them since our mobilization at Camp Atterbury from 1 March 2007 to 21 March 2007 and continued at Fort McCoy from 2 May 2007 until SFC Jenkins departed for R.R. During this period 1LT Chow never appeared to have a personal issue with SFC Jenkins.

Professionally SFC Jenkins and 1LT Chow regularly had disputes. These stemmed from SFC Jenkins firm belief that as finance "we gotta take care of soldiers" ~~and~~ mentality and 1LT Chow's lack of empathy or care for any service member that didn't owe him his. We had a soldier who had been medicined to our base, came into our office with cuts on his face, no clothes or belongings other than the boots on his feet and PT's and dog tags. He wanted to get a casual pay but needed an E-7 to sign it or a CAC card for P.O.D. SFC Jenkins was highly irritated with 1LT Chow's rejection of this soldier's need for cash and denying

him a casual, citing Regulations as why. SFC Jenkins took the soldier outside, signed his casual guy then insured and cashier payed it. 1LT Chow was angered by this and attempted to yell at SFC Jenkins about it. When she did SFC Jenkins proceeded to yell at her about her mis treatment of the soldier to the point she cried. This happened on multiple occasions where 1LT Chow would deny a soldier in need of money and SFC Jenkins would go over her head and take care of the situation. This normally ended in 1LT trying to get in her office.
