Dear Attorneys:

As you may or may not know, Equilon Enterprises, LLC, d/b/a Shell Oil Products U.S., through its attorneys DYKEMA GOSSETT, PLLC is defending an action pending in the State of Michigan Court of Appeals. However, it does not appear that DYKEMA GOSSETT, PLLC (1) intends to conduct itself in good faith; or (2) to defend on the merits.

DYKEMA GOSSETT, PLLC has circulated the enclosed letter positing that a represented party has committed bankruptcy fraud and that such party's attorneys are not authorized to file an appeal on the party's behalf. Regrettably, DYKEMA GOSSETT, PLLC (1) did not consult the party's bankruptcy attorney or civil attorney; nor (2) consult the bankruptcy code and pertinent case law prior to circulating this ill-conceived correspondence.
