18	A.	Twenty.
19	Q.	And did you go to school?
20	Α.	Yes.

23	Q.	Did you have opportunities to spend time with him at his
24		house?
25	A.	Yes.

24		very cuddly person. I would never turn down someone asking me
25		to cuddle.

2		you weren'tit wasn't something out of the ordinary for you?
3	A.	It would be like cuddling with a brother. It's
4	Q.	Okay.
5	A.	It doesn't mean anything more than that.
6	Q.	Okay. Do youyou said you're a cuddly person?
7	Α.	Yeah. I used to be.
8	Q.	That means you like to hug people and cuddle?
9	A.	(Non verbal response)
10	Q.	Okay. In terms ofhow would you characterize yourI think I
11		asked before but I just want to clarify thisyour
12		relationship with Richard: Was it a romantic one?
13	A.	No, not at all.
14	Q.	Was he aware of that?
15	A.	Yes.
16	Q.	How was he aware of that?
17	A.	He has told me several times that he was interested in me and
18		I told him, because I dated his best friend and because I did
19		see him as a bro, I would never have any of those feelings for
20		him.
21	Q.	That night in his bedroom, May 14 th /15 th I think your
22		testimony is probably on the 15 th , that would be shortly after
23		midnightyou came to his room. Is that correct?

25	Q.	And your intent was to spend the night in his bedroom?

3	Α.	I was wearing Transformer pajama pants and a yellow Pokémon

8		bed to cuddle; you were watching a movie, I think your
9		testimony is?
10	A.	We were watching Ren and Stimpy. It's a cartoon.
11	Q.	A cartoon. And ultimately what happened? Did you fall asleep
12		at some point in time?
13	A.	Yeah. I looked right at him and, you know, before I moved
14		back from Grand Rapids I got a concussion.

16	A.	And I told him between the concussion and the drinking and the
17		smoking, I probably just needed to go to sleep. And he told

17		up, you realized Richard was on top of you. I think you said

22		you make a report of this activity to the police?
23	A.	Yes, I did.
24	Q.	And did you go to Munson Medical Center as well?

3		THE COURT: Thank you, Mr. Hubbell.
4		MR. HUBBELL: Mr. Williams might have some questions

8		MR. WILLIAMS: Thank you.
9		CROSS-EXAMINATION
10	BY M	R. WILLIAMS:
11	Q.	Hi,
12	A.	Hi.
13	Q.	I've got to ask you some questions. It's my job. I'm not
14		here to give you a hard time or make you feel bad so I'm just
15		going to ask you some questions, okay? Now you did an
16		interview with the police and you said that Mr. Robinson
17		[sic.] was the first friend that you ever made?
18	A.	At Glen Lake, yes.
19	Q.	At Glen lake? Okay. How old were you at that time?
20	A.	I was about 17.
21	Q.	Okay.
22	A.	Sixteen or seventeen.
23	Q.	Whatyou also talked about that there was drama sometimes and
24		you'd get really upset with Richard sometimes?
25	A.	The only time I got upset with Richard was when he would blow

1		off me or any of his friends and I stuck up for all of us, not
2		just myself.
3	Q.	Okay. You would get upset with him when he'd blow you off?
4	A.	Or any of our friends.
5	Q.	Okay. Now you said you had just moved back from Grand Rapids,
6		correct?
7	A.	Yes.
8	Q.	Why did you move down to Grand Rapids?
9	A.	Because I wanted a fresh start. I wanted to get away from
10		here.
11	Q.	How come?
12	Α.	Because I'm not happy in Traverse City.
13	Q.	Okay. Was there a lot of drama going on in your life?
14	A.	I recently lost two friends so, you know, that's pretty hard
15		to deal with.
16	Q.	To drugs?
17	A.	No.
18	Q.	Accidents?
19	Α.	One died in the lake and the other died in a car accident.
20	Q.	Okay. Fair enough. Who were you living when you moved back
21		when you moved to Grand Rapids?
22	Α.	I was living with Annie Snedeker.
23	Q.	Okay. Is that a girl? Boy?
24	A.	That's a girl.
25	Q.	Okay. Was that a friend of yours?

 Q. How come you moved back up here?

3	Α.	Because I really missed my friends and the plan was Aiden and
4		my friend Vince and Jake were going to get a place together.
5		And Richie decidedme and Richie had decided that we could
6		get a place together this summer.
7	Q.	Okay. Gotcha. Now what did you guys-~you guys drove around
8		that day, correct?
9	A.	Yes.
10	Q.	Leading up to that? What did you guys do that day?
11	A.	We drove into Traverse City. We visited two of my friends and
12		went back to Empire.
13	Q.	Okay. Did you guys smoke marijuana that day?
14		
14	A.	Yes.
15	Q.	Do you remember maybe what time you guys started smoking?
16	Α.	I believe we started smoking at about 7:308:00 o'clock or
17		something like that.
18	Q.	In the evening?
19	A.	Yes.
20	Q.	Okay. Not prior to that but that's probably when you guys
21		starting smoking?
22	A.	Right.
23	Q.	7:30? Okay. Did you consume any other drugs or alcohol that
24		day?
25	A	No.

3	Q.	Okay. You just testified that because of the marijuana and
4		alcohol and your concussion, you were tired. Were you talking
5		about the alcohol you consumed the day prior?
6	A.	Yes.
7	Q.	Okay. All right. Now do you take any prescribed medications?
8	A.	No.
9	Q.	Okay. The concussion that you recently had, what happened
10		there?
11	A.	I hit my head on a pedal board at a rock concert.
12	Q.	Okay. Do you know what level of a concussion that was?
13	A.	I have no idea. They did not fill me in on a lot.
14	Q.	Okay.
15	А.	I know that I had it for exactly a week.
16	Q.	Do you remember what the symptoms were of it?
17	A.	I was incredibly tired all the time. I wasn'tI would often
18		stare off in a daze, almost like daydreaming.
19	Q.	Okay.
20	A.	My speech was slurred and I felt nauseous.
21	Q.	Okay. Did it cause you to have any lack of memory, do you
22		recall?
23	A.	No, it didn't.
24	Q.	Okay. Now the night before this incident, there was a party
25		at Richie's house. Is that correct?

2	Q.	Do you recall how many people were at the party?
3	A.	Twenty to thirty, in and out.
4	Q.	Okay. That night, do you redo you remember where you slept
5		at that party?
6	Α.	I slept withI slept out in the living room with Danielle
7		Leach and Nick Christianson.
8	Q.	Okay. And where did you sleep?
9	A.	On the pullout couch.
10	Q.	Who was on that couch?
11	Α.	Danielle and Nick Christianson.
12	Q.	Okay. So the three of you?
13	A.	Yes.
14	Q.	Were on that couch? Okay. Do you recall having any type of
15		intimate contact with Nick that night?
16	А.	No, I don't.
17	Q.	Is it possible that you did?
18		MR. HUBBELL: Your Honor, I'm going to object. I
19		don't know how this is relevant to the charges. First of all,
20		it's probably barred by the Rape Shield statute, although
21		we're not at trial.
22		And secondly, she's not on trial or at a hearing,
23		the defendant is and I don't think it's relevant for the
24		purpose of today's hearing.
25		MR. WILLIAMS: Your Honor?

1 THE COURT: Go ahead. 2 MR. WILLIAMS: This goes to credibility. She's 3 already testified -- or she's already given a statement that she 4 legitimately doesn't know what happened that evening and we 5 have an affidavit from this young man who has set forth that 6 they had a sexual encounter where she was sleeping and grabbed 7 his hand and put it on her crotch the night before this 8 incident occurred, which is very similar to what the 9 allegations are today. 10 It's absolutely relevant and we're looking at the 11 credibility of what occurred here. I don't see how this 12 couldn't be relevant. 13 THE COURT: Mr. Hubbell? 14 MR. HUBBELL: Again, your Honor, ultimately the 15 questions of credibility are determined at trial. You know 16 what your decision would be if I meet my burden. The problem 17 is, again, this alleged incident is probably protected by the 18 Rape Shield law. 19 And secondly I don't think it's relevant if Mr. 20 Williams is talking about an affidavit that's obviously not in 21 evidence. We don't have a witness. And again, questions of 22 credibility or for disputes in the facts and those issues are 23 ultimately to be resolved at trial. 24 THE COURT: That is true. 25

MR. WILLIAMS: Your Honor?

THE COURT: Go ahead.

MR. WILLIAMS: We're at an evidentiary hearing. You are obligated to look at the global picture here. I'm allowed to call witnesses. I'm allowed to cross-examine people. You have to take in the credibility of the witnesses. That's the whole purpose of this exam.

So again, we have these allegations that are identical to what Mr. Richie's [sic.] been accused of. So we need to at least get some testimony from Lissa on what happened. Because the parallels are so similar that I don't-this isn't a Rape Shield. We're not accusing her of anything. We're not saying it's a prior bad act.

This is just we're trying to figure out what happened here and that's the purpose of having a preliminary exam. We ask questions, we try to figure out what happened and see what the story is.

Is the Court not interested in credible, reliable information? I don't--I'm having a hard time trying to understand why this isn't relevant.

THE COURT: Well, the Court does--at a preliminary examination does have some responsibility with respect to determining the credibility of witnesses.

Although the ultimate issue is decided by a jury, this issue could be covered by the Rape Shield statute and I think it's of very minimal relevance, even if it were true

1	that she had some contact with this other individual.
2	MR. WILLIAMS: Even if it were true?
3	THE COURT: It's got nothing to do with unconsented-
4	-just hang on a second please. I'll allow you to ask the one
5	question. I think it can be covered with a yes or no answer,
6	okay?
7	MR. WILLIAMS: Thank you. Thank you.
8	THE COURT: Go ahead.
9	CROSS-EXAMINATION
10	BY MR. WILLIAMS:
11	Q. Do you recall placing Nick's hand on any part of your body?
12	A. Other than my side that he already had because there were
13	three of us in that bed, no.
14	Q. Okay. Do you recall kissing Nick that night?
15	A. NO.
16	MR. HUBBELL: Objection, your Honor.
17	THE COURT: I didn't even hear the question.
18	MR. HUBBELL: You said he could ask one guestion.
19	Now we're at two.
20	THE COURT: What was the question? Mr. Williams,
21	will you restate the question?
22	MR. WILLIAMS: I asked her if she recalled kissing
23	Nick that evening. Nick Christianson at Richie's house.
24	THE COURT: I'm not going to allow that question. I
25	don't see that that's relevant.

2	Q.	Okay. Where were your pants, do you recall how far they were
3		down?
4	A.	On justjust on top ofjust below my knees. Like just on
5		top of knees. They were still on my thigh, like right there,
6		yep.
7	Q.	Right here? (Indicating)
8	A.	Yep.
9	Q.	Okay. Well with your pants being on your thighs right there,
10		were your legs spread open?
11	Α.	Yes, a little bit.
12	Q.	Howwould the pants restrict that and the underwear?
13	Α.	No, they were elastic. My underwear was pulled down and I had
14		a button on my Transformer pants that was undone and I didn't
15		realize that until I'd gotten in the car and looked down.
16		(Crying)
17	Q.	Okay. Now thebut you felt some pressure.
18		(At 11:41 a.m. to 11:42 a.m., proceedings paused)
19		CROSS-EXAMINATION
20	BY M	R. WILLIAMS:
21	Q.	Is it okay to ask you a question?
22	A.	Yeah.
23	Q.	Okay. You felt pressure but you don't know what the pressure
24		was coming from, is that correct?
25	A.	No, I just told you. I know that his pants were down. I know

1		what pressure was Ithat I felt.

12	Q.	Okay. Lissa, have you ever slept walked?
13	A.	No.
14	Q.	Walked in your sleep? Do you know if you have a history of
15		ever being active in your sleep?
16	Α.	I know that there was a time, like I said, after my friend
17		Nick died and I was going through a lot, that people could
18		talk to me in my sleep. They would start the conversation and
19		I would talk back. But that's it.
20	Q.	Okay. Do youwhen those types of incidences occurred, do
21		youdo you remember talking to those people?
22	A.	No.
23	Q.	Didwould they have conversations with you?
24	Α.	Yes. They would always initiate the conversation first and I
25		would just reply.

1	Q.	Okay. And you would have a full conversation while sleeping?
2	A.	Yes.
3	Q.	Okay. All right. On that morning when RichieI'm sorry.
4		That morning when Richie left, didyou contacted Aiden on
5		Facebook, is thatis that correct?
6	A.	Yes.
7	Q.	Okay. Whose computer did you use?
8	Α.	Richard's.
9	Q.	Okay. Did you contact anyone else on Facebook that morning?
10	A.	No, I did not.
11	Q.	Okay. Diddo you know if they had a land phone line at their
12		house?
13	A.	Yes, but I'm well aware that his mother and step-father don't
14		like me so I was already in an uncomfortable position. I
15		wasn't going to ask for anything.
16	Q.	Fair enough. I justokay. I understand. Thiswas everyone
17		else in the house sleeping when this happened?
18	A.	Yes, it was his mother and his step-father.
19	Q.	And they were asleep?
20	Α.	Yes.
21	Q.	Okay. Did you haveall right. I'mand thatjust a couple
22		more questions, I'm done. Earlier in the night, you started

4	Mr. Hubbell?

8	follows)
9	DIRECT EXAMINATION
10	BY MR. HUBBELL:
11	Q. Sir, could you state your name for the record?
12	A. Richard Clinton Kerr, Junior.
13	Q. And how are you employed?
14	A. I'm a Detective Sergeant with the Leelanau County Sheriff's
15	Office.
16	Q. And how long have you worked for Leelanau County?
17	A. Twenty-four years.
18	Q. How long have you been in the position of the Detective with
19	Leelanau County?
20	A. Close to seven years.
21	Q. And in terms of being a Detective Sergeant, has that been a
22	recent designation?
23	A. Almost a year.
24	Q. Okay. As part of your duties as detective with the Leelanau
25	county Sheriff's Department, are you involved with the
1	35

1		investigations of allegations of Criminal Sexual Conduct?
2	A.	Yes.
3	Q.	And in that capacity, did you have an opportunity to speak to
4		a Richard Robertson?
5	A.	I did.
6	Q.	And do you recall what day you spoke with him?
7	Α.	May 17 th of this year.
8	Q.	And where did that conversation take place?
9	A.	In our interview room in our Sheriff's Office.
10	Q.	And was that conversation recorded?
11	A.	Yes.
12	Q.	And can you briefly tell the Court how you became involved in
13		the investigation?
14	A.	I was called the previous night when the incident was reported
15		by the deputy who was assigned the complaint. I met with him
16		at Munson Medical Center but didn't take any investigative
17		action that day. The next day, we had drafted a search
18		warrant for the residence but didn't end up serving it.
19	Q.	When you say the deputy, who was that deputy?
20	A.	Terrance Cadieux.
21	Q.	Okay. So you were going to draft a search warrant and serve
22		it on the residence but you didn't. What did you do instead?
23		What was done instead?
24	Α.	We set up an interview with Mr. Robertson to come in and speak
25		with us at the Sheriff's office and after we spoke with him,
I	I	26

1		we ended up not serving a search warrant so it was returned to
2		the Court unserved.
3	Q.	Okay. When you say, "We spoke to him," did you and Mr
4		Deputy Cadieux speak to him at the same time or was this done
5		separately?
6	Α.	Deputy Cadieux interviewed him initially and then I spoke to
7		him after that.
8	Q.	And during the course of speaking with Mr. Robertson, I assume
9		the topic of conversation was what we're here today for?
10	Α.	Yes.
11	Q.	And what was your purpose in talking to him?
12	Α.	I viewed the interview that Deputy Cadieux had with Richie and
13		he just wasn't telling the truth in my opinion. So I spoke to
14		him after the deputy did.
15	Q.	Okay. In other words, what you were hearing Mr. Robertson
16		telling Deputy Cadieux didn't add up in your mind?
17	Α.	Yes.
18	Q.	And so you went in to speak to Mr. Robertson?
19	Α.	I did.
20	Q.	Was he under arrest at the time?
21	A.	He was not.
22	Q.	Was he in handcuffs?
23	Α.	No.
24	Q.	What did you and Mr. Robertson talk about?
25	A.	I trust told him I didn't believe what he was saying.

1	Q.	What was he telling Deputy Cadieux?						
2	Α.	That basically Lissa initiated sexual contact with him while						
3		she was in her sleep. Sleep sexing, I believe is the word.						
4	Q.	Okay. And you told Mr. Robertson you didn't believe his						
5		story?						
6	A.	Yes.						
7	Q.	And ultimately what was his response to you?						
8	Α.	He maintained that that's what happened for a short period of						
9		time and then he eventually told me that that wasn't the						
10		truth.						
11	Q.	Did he make a statement to you originally that the victim in

And I think that cons--and the defendant knew or should have reasonably known that she was in that condition and therefore, at least for the purposes of the preliminary examination, I think evidence has been presented which would support the bind over.

THE COURT: Okay. Thank you. Mr. Williams? MR. WILLIAMS: Yes, your Honor. I agree with Mr. Hubbell except for one count for the bind over. Where's the second count? The victim testified and was very clear that

l she felt pressure. Pressure, one time. There's zero 2 testimony from the victim of digital or multiple penetrations. 3 I wholeheartedly object to a bind over on two counts 4 and I am quite certain that the record does not support it so 5 I agree that one count is probable and necessary for this 6 proceeding, but there is not enough evidence to support two 7 counts. 8 THE COURT: Mr.--9 MR. HUBBELL: Judge, I respectfully disagree. Ι 10 think the digital penetration occurred while the victim was 11 still in a deep sleep and that was admitted to by the 12 defendant to Detective Kerr. 13 Once he started to climb on top of her and attempted 14 to, and did in fact, put his penis in her vagina that -- at 15 which time, that is when she woke up. The other acts of 16 penetration occurred while she was asleep. 17 MR. WILLIAMS: Your Honor, Detective Kerr--that's 18 not accurate. Whether it be digitally or penilely [sic.], or I 24 don't if that's the right word. 25 THE COURT: Well, I very clearly heard Detective

Kerr say that the defendant told him that he put his finger in her first. She woke up and then he put his penis in her. There was some reference to small and loss of erection or what have you, but he did say that the defendant told him that he did his finger in her, she woke up, and then he put his penis in her.

She said that she felt pressure in her vagina and, while upset, told you that she knows that he did put **his**-at least his penis in her.
