- 6. Scope, Findings of Fact, Conclusion, and Recommendation:

a. Scope

(1) Commanding General, Marine Air Ground Task Force Training Command, Marine Corps Air Ground Combat Center directed the Command Inspector General to investigate the allegations of misconduct at the Provost Marshal's Office.

(2) Allegations:

- (a) <u>ALLEGATION #1</u>: That official incident reports are being altered by supervision after completed and turned in by patrol officers at PMO, a violation of MCO 5580.2D, during the period 1 January 2007 to 17 August 2009.
- (b) ALLEGATION #2: That an Official Civilian Payroll Time Sheet was altered without authorization by Lieutenant Daly, Civilian Police Officer after completed and turned in by Officer Mills, Civilian Police Officer at PMO, a violation of DoD 7000.14-R, during the period 1 January 2007 to 17 August 2009.
- (c) ALLEGATION #3: That Lieutenant Daly, Civilian Police Officer communicated personal and private information about Officer Mills background investigation to Civilian Police Officers, a violation of the Privacy Act of 1974 in May 2009.
- (d) <u>ALLEGATION #4</u>: That PMO personnel are mistreated, embarrassed, hazed, and threatened by supervision at PMO, a violation of MCO 1700.28, during the period 1 January 2007 to 17 August 2009.
- (e) <u>ALLEGATION #5</u>: That apprehended personnel are being unlawfully detained at PMO, by PMO personnel, a violation of MCO 5580.2D, during the period 1 January 2007 to 17 August 2009.
- (f) ALLEGATION #6: That Major Scarselli and Master Gunnery Sergeant Humbertson hosted alcohol related social functions on the installation at PMO, Buildings 1407 & 1408, to include underage consumption, a violation of MCO 1700.22E and CCO 1720.1H, during the period 1 January 2007 to 17 August 2009.

- (g) ALLEGATION #7: That PMO is permitting gambling on the installation at PMO, Buildings 1407 & 1408, a violation under Article 134 of the UCMJ, during the period 1 January 2007 to 17 August 2009.
- (h) ALLEGATION #8: That PMO personnel have submitted false training records to Headquarters Battalion by direction of Major Scarselli and Master Gunnery Sergeant Humbertson, a violation of Article 107 under the UCMJ, during the period 1 January 2007 to 17 August 2009.
- (i) ALLEGATION #9: That a hostile work environment exists at PMO, to wit SSgt Brookins uttered racial slurs and committed sexual harassment to members of PMO, a violation of MCO P5354.1D, and MCO 1000.9A, during the period 1 January 2007 to 17 August 2009.
- (j) ALLEGATION #10: That unfair hiring practices were permitted for selecting civilian police officer positions at PMO, a violation of 5 U.S.C. 2301(b) and 5 U.S.C. 2302(b), during the period 1 January 2007 to 17 August 2009.
- (k) ALLEGATION #11: That PMO personnel are committing adultery with spouses of military personnel, a violation under Article 134 of the UCMJ, during the period 1 January 2007 to 17 August 2009.
- (1) <u>ALLEGATION #12</u>: That Major Scarselli has been borrowing money from subordinates at PMO, a violation of Fraternization under Article 134 of the UCMJ, during the period 1 January 2007 to 17 August 2009.
- (m) <u>ALLEGATION #13</u>: That Major Scarselli and Master Gunnery Sergeant Humbertson have been fraternizing by living together under one roof, a violation under Article 134 of the UCMJ, during the period 1 October 2008 to 17 August 2009.
- (n) ALLEGATION #14: That Major Scarselli authorized the issuance of an Installation Access Card to Mr. Robert T. Lemons, an applicant with an outstanding criminal warrant, a violation of MARADMIN 533/08, CCO 5512.2D, and PMI 74 on 7 July 2009.
- (o) ALLEGATION #15: That Major Scarselli and Master Gunnery Sergeant Humbertson knowingly communicated false information to the Command Inspector General, a violation under Article 107 of the UCMJ, during the conduct of this official Commanding General investigation, 11 May 2009 to 17 Aug 2009.
- (p) ALLEGATION #16: That Major Scarselli interfered with an official Commanding General investigation by contacting witnesses to discover what was asked and their responses to determine if he, or Master Gunnery Sergeant Humbertson, were implicated after being instructed by the Command Inspector General, and after receiving a direct order from Colonel Green, AC/S, G-7, a violation under Article 92 of the UCMJ, during the conduct of this investigation 11 May 2009 to 17 August 2009.

- b. Findings of Fact for Allegation #1. That official incident reports are being altered by supervision after completed and turned in by patrol officers at PMO, in violation of MCO 5580.2D, during the period 1 January 2007 to 17 August 2009.
- (1) That Military Police/Police Officers shall submit all reports as truthful, complete, and no report shall knowingly contain any inaccurate, false, or improper information. (Encl 133)
- (2) That Staff Non-Commissioned Officers (SNCO's) are making corrections to reports from their office without being on the scene. (Encl 146)
- (3) That electronic reports in CLEOC are reviewed by Level III Watch Commander and Level IV access, Platoon Commander, who can make changes to the content of a report. (Encl 53, 60)
- (4) That Staff Sergeant Brookins has held billets as Watch Commander, Platoon Commander, and again Watch Commander during his tour at PMO. (Encl 94)
- (5) That Staff Sergeant Brookins instructed Officer Jolly to make changes in his report that do not accurately reflect what happen, even though Staff Sergeant Brookins was not present at the call. (Encl 2)
- (6) That Staff Sergeant Brookins instructed changes in the report tend to be legally significant changes, line up times and dates, or make the accused appear guiltier. (Encl 2, 4, 6, 8, 11, 15, 16, 22, 25, 72, 80, 93)
- (7) That Staff Sergeant Brookins has PMO personnel write in their reports that a search and seizure was consensual, even if it were not. (Encl 2, 72, 80, 93, 96)
- (8) That Level IV approving officials, Staff Sergeant Brookins, and other Watch Commanders, can make changes to an official incident report without notifying the originator. (Encl 94)
- (9) That Staff Sergeant Brookins paraphrased a Marine stabbing victim from a beer bottle, instead of a word for word response from the Marine in the report as seen by Lance Corporal Kiser, MP. (Encl 6)
- (10) That Staff Sergeant Brookins changes the flavor of the report to impact the outcome, the guilty become innocent, and the innocent become guilty. (Encl 8, 15)
