

I am coming on December 20, 2011. I Hope I will arrive safely. Soon I will receive an E-mail from you, I will send you my New phone Number. I am coming from Beirut, Lebanon in Air France. the first couple days, you can call me on my son phone Number = 248. 9300466.

- I have the right to file a formal discrimination Complaint based on Sexual Harassment, Committed by General Rodriguez, LT security officer Samantha Schoden and Major Sergeant Ortiz, and other of his team.

the most recent claim<sup>2</sup> involved that:

1- they put my life in danger, through spreading news here in Lebanon to the enemy of U.S, that I worked with the Congress which I never did, and I worked with the Intelligence which I denied. I saw the boyfriend Tony Mubasat, the married boyfriend of LT Samantha Schoden, followed me in a resort in North Lebanon; and other things....

2- June 23, 2010 = abuse of power and misconduct by using their power, they forced a research Dr Andrew Russman in Henry Ford Hospital who I met him in the hospital a week before, to let another Dr Espiritu, a psychiatrist, which I never met to take me down to the basement. For No Reason or right, he holded me for four and a half in a waiting room, with my son. Dr Russman told Dr Nour, a cardiologist who is friend of mine who called him that "his ass, Dr Russman Ass is in big danger if he doesn't take me down". And Dr Russman Confessed to Dr Nour that this psychiatrist Espiritu waiting for me to write a false report about me. Dr Nour came and release me... but this report they need it, which never Happened to Switch another false report, trying to force Major Monique McCoy to write a false report, demanding from Mike Marinos, the site manager of L3, who I hearding him asking this Major who refused to write the

false report by the Order of the general, because she told him that I am normal person more than her and Mike Marinos, plus she never asked me any questions, or check me out. I saw her only in the waiting room when I was talking to the receptionist, asking her what kind of clinic is here? Major McCoy stood up from her chair and recognized that is a set-up yelling on the receptionist to called this son of b... My symptom was a stomach pain. Major Monique warned me a lot. After 10 minutes of this incident, I resigned. Specially my father was a doctor, which he will never write a false report, or a true report if he doesn't check the patient or examined him.

— Two brake-ins in my restaurant in four months, which I don't have millions in it. They caught the criminals, but the insurance Hartford switch the adjuster and this because of their interference the second claim never was paid till now, and the adjuster has a doubt about the police report, the health department... this was on December 2009. I supported him with all the documents and he asked for the same documents again and again, so he will have an excuse not to pay me. And I supposed to sale my food

To Cosco Wholesale. but this when I gave up after a company named Acclaim technical services promised to hire me as a contractor with top secret and sent me to Washington doing two tests and I passed. And my trip was paid American Express by an Army person named Niles. After two years, Acclaim technical services confessed that on their computer shows that I cannot work as a contractor. So I gave up and I opened my restaurant who they ruined to.

- gross violation of my security clearance  
check the expiration date of my CAC, check the application of different dates of the expiration, check the dates of the orders, check the confirmation after seven months of that, through my security officer of my company named Brian Brickmore who sent me after checking in Washington, that I am still have the same clearance of S14 I went to Iraq with. Washington confirmed to him that my clearance has not changed a bit and I am fine. who gave him the right to touch my security clearance without any reason, Washington and my knowledge

- they prohibited me<sup>5</sup> from having an attorney to defend myself, after they promised me when they read my documents; because of their interference, they refused and the example of one attorney who I know long time, promised after he read my documents that he can and will bring the top person in the government to justice. This attorney asked me for twelve thousand and five hundred dollars for retainers and I did send him the money from Beirut, Wireless to his account, and I have the receipt. This attorney named William Donovan. I have to sell my last property of my father Heredity to access to justice. And the shock is when he sent me an E-mail to forget about it, and he sent me a wrong Complaint for this Hospital and Doctors, instead to make the Complaint for the two doctors, against them and the hospital to hold 4 1/2 hrs. This attorney covering these doctors due to their interference, and is suing the Security Guards instead who they never touched me. He sent me an e-mail telling me to lie. So I sent him 3 times the Correction for his Complaint, he refused and when I asked him to send the difference to calculate the two meetings and one phone call from Lebanon which I pay,

for it. he refused and asked me for twenty thousand dollars billing. I want to know if I am really living in a real and correct world and where is the justice ?? ??...

- they ruined my credit cards, and destroyed my life. You can check my thirty two years before I went to Iraq, and why the counter intelligence gave me \$14, because I deserved it. And I want it back. And check my credit after I came from Iraq. I used to write a check in the restaurant or personal, after it is cashed, two weeks later it will come back, how, I never knew till I watched the movie "the enemy of the state". I used to go back and forth to the bank. - I am a good U.S citizen who want to live a normal, clean, correct and I lost enjoyment of life as a human being they stole my liberty and my freedom.

Thank you for your letter, postmarked October 19, 2011, to the Office for Victims of Crime describing the trauma and extreme situations you experienced while serving in Iraq as a United States citizen in support of the Army. I can understand how these events would have a severe impact on your well-being, and I would like to offer my sympathy for your present situation.

The Office for Victims of Crime (OVC) is a component of the U.S. Department of Justice and supports the provision of services to crime victims. Unfortunately, OVC does not become involved in individual cases; however, I can recommend some resources and referrals that may be useful to you.

There are military resources that might be helpful with some of the issues you discussed in your letter. You should be aware, however, that the military components generally have regulations that require you to apply for relief within a specific period of time. If you consider using these resources, please do not delay in initiating your complaint and appeals.



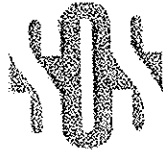

Dear Faten:

Congratulations! You have passed the initial CI screening and medical exam to work with us in support of *Operation Enduring Freedom*. Your employment with SOSi officially begins on the day that you deploy to CRC/Ft. Benning, Georgia. Please note, however, that your continued employment is still contingent upon your ability to pass the final screening conducted by the Government, as well your ability to receive a interim SECRET level and a final SECRET level security clearance.

You are permitted to bring one additional bag and a carry-on for the trip to your assigned location. While there, you will wear a military uniform when working and sleep and eat in the Army facilities.

Your base salary will be \$90,000.00 per annum for a CATII linguist. In the event you are denied interim access you will be re-classified as a CATI linguist and your pay will be adjusted accordingly, please refer to the addendum on page 2. You will receive 25% "Hazard Duty Pay", and at least 10% Post Hardship Differential upon arrival in Iraq (AOR). You may be eligible to receive up to an additional 10% Post Hardship Differential based on your location and assignment in Iraq (AOR). The total base pay plus 35% Hazard Duty/Hardship Pay will be \$121,500.00 per annum. Also, Operations, Awards and completion payments will be paid on or about your quarterly anniversary of your arrival into the theater of operation, not on your date of hire. After completing 30 days of employment in theatre you will receive a \$10,000 signing bonus. Upon completion of 6 months of continuous employment in theatre, you will receive a \$10,000.00 completion payment; thereafter, with the completion of another 6 months of continuous employment (total 12 continuous months) you will receive an additional \$10,000.00 completion payment. After 6 months of service overseas, you will be eligible for a vacation travel allowance of up to \$2,000.00 per calendar year.

After completion of 12 months of continuous service in Iraq (AOR), you will be paid a new sign on bonus of \$10,000, if you recommit to an additional one year of service in Iraq (AOR). The recommit bonus will be paid 30 days after the start of the recommit period.

New employees receive their first paycheck after the second payroll cycle following their first day of work. In your assignment you are expected to be on duty 12 hours per day, 7 days per week and you will be on call the remaining 12 hours in each day. In this position you will be a salary exempt employee and no overtime pay is authorized.

During your assignment in Iraq you may report to a non-SOSi Manager (either Titan Corporation, our prime contractor, or directly to the Military), who will delegate your work assignments and periodically review and evaluate your job performance.

You will become eligible to participate in our Health Insurance Plan on the first day of the month following your official date of hire. Depending on the health plan coverage option you select, i.e. (single, employee + dependent, employee + child(ren), or family coverage), you may be required to make a biweekly contribution towards the cost of insurance. Please refer to the SOSi Health Insurance Plan rate sheet enclosed with this letter for additional information regarding the health insurance plan contribution rates. If you opt not to participate in the Health Insurance Plan, you will receive a pay differential of up to \$3,162.00 per year. This amount will be added to your gross taxable income. If you decide to opt for the

pay differential in lieu of group insurance participation, you will be eligible to receive these payments the first of the month after completing two months of employment.

You will be eligible to enroll in the SOSi 401(K) plan the first calendar quarter upon completion of three (3) months of employment and can elect to make tax deferred contributions to the Plan. Upon completion of one year of continuous service, you will be eligible to enroll in the SOSi Pension Plan. The terms and Provisions of the Pension/401K Plan are described in the SOSi Summary Plan Description (SPD). Since you are covered by the comprehensive Defense Base Act, (DBA), while deployed with the military, you are not eligible for the U.S. based short-term disability policy referenced in the Employee Handbook.

This initial assignment is expected to last approximately one year. However, SOSi International Ltd. does not guarantee the term of this assignment. There may be instances where customer requirements necessitate either an extension of the assignment or the termination based on project requirements. In such cases, we will inform you of the nature of the change, and work with you to satisfactorily extend or terminate your assignment including any return to the United States to make arrangements or to return home permanently. Should you decide to terminate your employment with SOSi voluntarily before the completion of six months of duty, you may be liable for all travel costs associated with your return to the United States. This letter does not create a contract of employment between you and SOSi for any specified period of time.

You will be eligible for two (2) weeks of vacation, ten (10) paid holidays and four (4) personal days for each year of service, for a combined total of 24 paid leave days which will be accrued ratably each bi-weekly paid period during the calendar year. You have the option to either utilize your accrued leave or sell it back to the Company any time after it is earned.

# **Foreign Government Information (FGI) SECURITY BRIEFING**

## **FOREWORD**

This sample security briefing contains the minimum elements of information that must be provided to individuals upon initial indoctrination for access to FGI classified information. Contractors are encouraged to expand upon this briefing to accommodate specific situations. There is no requirement to copy this format or literary style; however, the minimum elements contained herein shall be included. Detailed procedures are contained in Chapter 10 of the National Industrial Security Program Operating Manual (NISPOM).

## **INTRODUCTION**

You will require access to foreign government classified information in pursuance of your current duties. The security standards and procedures for handling and protecting FGI are basically equivalent to those for U.S. information. This briefing explains the basic security standards and procedures for safeguarding classified FGI.

## **WHAT IS FGI?**

FGI is a.) information that has been provided to the U.S. by a foreign government or governments, an international organization of governments, or any element thereof with the expectation, expressed or implied, that the information, the source of the information, or both, are to be held in confidence; or b.) produced by the U.S. pursuant to, or as a result of, a joint arrangement with a foreign government or governments, an international organization of governments or any element thereof, requiring that the information, the arrangement, or both are to be held in confidence.

## **ACCESS AUTHORIZATION**

PCLs and FCLs issued by the U.S. government are valid for access to classified foreign government information of a corresponding level. Access to Spanish RESTRICTED information requires a U.S. CONFIDENTIAL clearance. Access to all other foreign government RESTRICTED information does not require a security clearance, although

a facility still requires a FCL. Access is based on need-to-know and an FGI briefing; and for access to CONFIDENTIAL FGI and above, the proper level of U.S. clearance. Ensure that access is limited to only those persons who require access for the purpose for which the information was furnished by the originating government. Remember, IT IS YOUR RESPONSIBILITY to ensure that an individual is authorized access to classified foreign government information BEFORE you provide access. If in doubt, seek assistance from your security officer.

### **CLASSIFICATION MARKINGS**

Foreign government information must retain its original classification, or be assigned a U.S. classification designation that will provide protection equivalent to that provided by the furnishing government or organization. When FGI is received, it is to be marked with the equivalent U.S. classification and the country of origin in English, unless it is already marked. FGI generally parallels U.S. security classification designations. However, some foreign governments have a fourth level of classification, RESTRICTED, for which there is no equivalent U.S. classification. Therefore the information is to be protected and marked as "CONFIDENTIAL-MODIFIED HANDLING". Spanish RESTRICTED information is to be marked CONFIDENTIAL. When unclassified foreign government "in confidence" information is involved in an international program, program documentation should include procedures on handling the information. Foreign Marking equivalents are provided in Appendix B. of the NISPOM.

### **CONTRACT SECURITY REQUIREMENTS**

The foreign entity that awards a classified contract is responsible for providing appropriate security classification guidance and any security requirements clauses. A report should be submitted to DSS if classification guidance has not been received. When a U.S. contractor enters into an agreement with a foreign entity that involves classified information, security requirements clauses will be incorporated in the subcontract document. Two copies of the signed contract with the clauses and the classification guidance shall be provided to DSS.

## DISCLOSURE

Foreign government information cannot be disclosed to nationals of third countries, including intending citizens, or to any third party. A third country issue may be involved for employees with dual citizenship. FGI cannot be used for other than the purpose for which the foreign government provided it without the originating government's written consent.

## SAFEGUARDING FGI MATERIAL

**General** Foreign government material shall be stored and access controlled generally in the same manner as U.S. classified material of equivalent classification. Foreign government shall be stored in a manner that will avoid commingling with other material, which may be accomplished by establishing separate files in a storage container. All personnel with access to a security container that is used to store FGI must be briefed and authorized access to the level FGI that is stored in that container. Annual inventories are required for Top Secret and Secret material. Foreign Government RESTRICTED material may be stored in a locked filing cabinet, book case, desk or other such container, or in a room or building that is locked during non-duty hours, provided access to the room or building is controlled so that only authorized personnel can gain access to the information.

**Transfer Foreign** government information shall be transferred within the U.S., its possessions, or territories, using the same channels as specified in the NISPOM for U.S. classified information of an equivalent classification. Uncleared commercial delivery services shall not be used. The transfer of classified FGI and unclassified foreign government information provided in confidence to areas outside the U.S. shall be through government-to-government channels. The ITAR requires a license for the commercial export or reexport of FGI unless the information is exported (as is, with no changes) to the original source of import. Foreign government information shall not be exported to a third party without the prior consent of the originating government.

**Automated Information Systems (AIS)** Systems that have been accredited to process U.S. classified information may be used to process FGI of the equivalent classification level.

## **DEFENSIVE TRAVEL BRIEFING**

---

### **PURPOSE**

As a cleared contractor employee, you have access to critical U.S. government information. The purpose of this briefing is to ensure that you understand your responsibilities to protect the information, and to make you aware of security vulnerabilities associated with foreign travel.

Presidential Decision Directive/NSC-12 "Security Awareness and Reporting Foreign Contacts", requires security personnel to establish and maintain security awareness programs which include formal briefings of the threat posed by foreign intelligence services. The awareness program must focus on the intelligence gathering of classified as well as other sensitive information. This Defensive Travel Briefing is part of BTG, Inc./Titan Security's Awareness Program.

---

### **APPLICABILITY**

This defensive travel briefing is required by DAO-207-1. When traveling abroad, cleared contractors are required to receive an annual defensive travel briefing. Any individual returning from travel of 90 days or more must undergo a security debriefing upon their return to the U.S.

### **AREAS OF INTEREST**

Within BTG, Inc./Titan, we possess a wealth of information of interest to foreign powers and entities. Information regarding the ongoing negotiations, industrial resources, production capabilities, manufacturing and other critical technologies, satellite data, telecommunications and computer science information, as well as numerous other types of sensitive information may be sought. Because of your access to personnel, facilities, and information, YOU, as a BTG, Inc./Titan employee, present an opportunity for a foreign entity to expand their knowledge about U.S. technology, capabilities and vulnerabilities. The information contained in this briefing regarding possible intelligence collection may occur in countries with whom we are allies. For that reason, we ask you to be alert to your surroundings and aware of your actions at all times wherever you travel internationally.

## **THE NATIONAL SECURITY THREAT LIST**

The FBI considers the following to be threats to our national security regardless of the country involved:

Any foreign intelligence activity which is:

- \* targeting U.S. intelligence and foreign affairs information and U.S. Government Officials
- \* directed at critical technology
- \* directed at the collection of U.S. industrial proprietary economic information
- \* directed at the collection of information relating to defense establishments and national preparedness
- \* involving the proliferation of special weapons of mass destruction
- \* involving perception management and active measures

If you become aware of or suspect any foreign intelligence activity aimed at the above list notify your Security Officer.

## **PRIOR TO DEPARTURE**

1. Contact your Regional Security Officer (703-383-6407) or the Office of Security (703-383-4239) to obtain the most recent travel advisory information. You may also want to contact the Department of State recorded messages at 202-647-5225.
2. Carefully complete your Visa application, as it will be scrutinized. If you are a naturalized U.S. citizen returning to the country of your origin, your citizenship may be questioned. If you encounter such a problem, please contact the State Department for guidance.
3. Ensure that items you carry with you are not controversial or prohibited. Political material or anything that could be considered pornographic should not be carried. If you carry prescription drugs with you, be certain that they are clearly marked and bring only necessary quantities.
4. Carrying letters, packages or gifts to individuals in other countries should be avoided. You may be viewed as a courier attempting to bring the material for subversive or illegal purposes.

5. **DO NOT TAKE CLASSIFIED MATERIAL** with you as you travel. Arrange to have the material transmitted by other means prior to your departure. Consult with your Security Officer for guidance.

6. Limit the amount of identification that you take. If you have several forms of Government ID (i.e. Commerce ID, building pass, courier card), bring only one ID with you. Make a photocopy of any ID or credit card you will be bringing and leave the copy at home. Write down your passport number and keep it separate from your passport. Do the same with your address and telephone.

7. The carrying of laptop computers is discouraged, but not prohibited. Consult your Security Officer and your Information Technology Security Officer if you plan to take laptop.

### **UPON ARRIVAL**

1. An accurate declaration of all money and valuables should be made at entry. Some countries give the traveler a copy of the declaration, which must be surrendered upon leaving. It is important to keep receipts of all money exchanges, these frequently are required upon departure. Undeclared sums of U.S. or other currency are likely to cause difficulty with authorities and may be confiscated upon departure.

2. Declare such items as cameras, radios, etc., to preclude possible explanations, customs charges, or confiscation when you leave.

3. Contact the American Embassy or Consulate prior to your arrival, and provide your local address and the probable length of your visit. For most official business visits a cable should be sent to the appropriate Embassy advising of your visit.

4. Use of public transportation is recommended rather than driving yourself, because involvement in traffic accidents can be problematic. Taxis are the preferred mode of transportation. State Department travel advisories provide updated information regarding public transportation concerns in the country you are visiting.



## **YOUR ACTIVITIES AND BEHAVIOR**

1. In all of your activities, show discretion and common sense. **MAINTAIN A LOW PROFILE.** Refrain from any behavior that may make you conspicuous or a potential target. **NEVER** engage in any illegal activity, excessive drinking or gambling. Use your best judgment to carefully avoid any situation which may allow a foreign intelligence agency the opportunity to coerce or blackmail you.
2. Do not discuss classified or sensitive information in any vehicle, restaurant, hotel room, hotel lobby, or other public place. In any public place, your conversation may be overheard, or you may be monitored. If you need to call the U.S. to discuss classified or sensitive information, locate a secure telephone by contacting the Regional Security Officer at the U.S. Embassy.
3. If you locate any possible surveillance equipment, such as microphones, telephone taps, miniature recording devices, or cameras, do not try to neutralize or dismantle it. Assume the device is operable and that active monitoring is ongoing. Report what you have found to the U.S. Embassy or Consulate. When you return, advise your security officer.
4. Never leave luggage or briefcases that contain classified or sensitive information unattended. This includes leaving your briefcase in your hotel room. We encourage you to keep your briefcase containing sensitive information, immediately in your possession. Departmental personnel frequently report occurrences of their luggage or briefcase being searched or rummaged through. If this happens to you, report the incident to your Security Officer when you return.
5. Foreign Intelligence Services may place you under physical surveillance or you may suspect that you are being watched. It is better to ignore the surveillance than attempt to lose or evade it. In any event your actions should be prudent and not likely to generate suspicion. Good precautionary measures are to use well-traveled highways and avoid establishing routine schedules.
6. Never try to photograph military personnel, installations, or other "restricted areas". It is best to also refrain from photographing police installations, industrial structures, transportation facilities and boarder areas.
7. Beware of overly friendly or solicitous people that you meet. Do not establish personal or intimate relationships with these individuals as they may be employed by the intelligence service. Do not share any work related information with any person who does not have a need to know.
8. Do not accept packages and agree to transport them back to the U.S. Even if your friends, relatives, and professional contacts, make the request, do not accept the package.

9.If you will be on an extended visit and expect to be writing or receiving mail, remember that it may be subjected to censorship. Never make references to any classified or sensitive information.

10.Avoid any areas where there is political or ethnic unrest, demonstrations or protests.

11.Should you be detained or arrested for any reason by the police or other officials, be cooperative, and contact the U.S. Embassy or Consulate immediately. Do not make any statements or sign any documents you do not fully understand until you have conferred with an Embassy representative.

12.Do not leave documents in hotel safes.

13.You may keep this document for reference, but do not carry it with you.

#### UPON YOUR RETURN

Contact your Security Officer to report foreign contacts and any unusual incidents. You must receive a security debriefing if you have been abroad for more than 90 days. You are required to report all contacts with individuals of any nationality, either within or outside the scope of your official activities in which:

\*Illegal or unauthorized access is sought to classified or sensitive information

\*you are concerned that you may be the target of an actual or attempted exploitation by a foreign entity.

#### EMERGENCY NOTIFICATION PHONE NUMBERS

Before your departure, it is recommended that you provide your family and/or a close friend with the name and phone number of your supervisor or coworker so that you can be reached in the event of an emergency.

If an emergency does occur, persons needing to reach you should be instructed to contact you via your immediate office. If this is not possible, the 24-hour State Department Operations Center at 202-647-1512, may be able to assist others in reaching you.

- 1- Rick Abner = Site manager at taji base, Iraq Ex-army who forced me fraudly to replace my CAC GSE14 to different one seven months before the expiration date. he threaten me with the general to many times.

- 2- Mike Marinos = Site manager at taji base, Iraq Ex-Army, who set me up big time, took me to a mental clinic as a medical clinic. And gave the order from the general to Major Monique McCoy to write a hidden false report concerning me without any examination, or check-up.

- 1- Tony Mubasat DoD, was the boyfriend of Samantha Ashoden 1LT, MI, Special Security officer. He was married and this is against the law.

- the 2 sexual Harassment Committed by the General Rodriguez in June 2005, at the palace of Fob courage APO AE 09354. during my job, in Iraq. After 12 hours working in my office C2X. the team of the General Captain Peterson, Captain Morriss and others, tried to force me that they are coming to my room to pick me up at 12:30 Am after midnight, because the General wants me, and I should come to his suite. and to be ready at this time: <sup>to pick me up.</sup> First I went to my boss office LTC Colonel Kelly. Hodges He wasn't there due to a business meeting. I found a classified linguist like me named Jack, he work now at the U.S Embassy to replace me. He accepted, but the shoke was from Captain Peterson in front of Captain Lewis and other Captains, who jumped on me from his desk and pointed

with his fingers to my face: "the general wants you, the general wants you, the general wants you." three times Captain Peterson repeated louder, <sup>the general wants to have some fun...</sup> refusing to replace me by Jack the classified linguist. Even so, I wasn't the linguist for the general. He did have three formal linguists. And by accident, I saw one of the general linguist, at 4:00 o'clock pm. He was a Captain in the U.S Army D'origine Egyptian, same day leaving the palace early at 4:00pm, because he doesn't have any work, he is leaving early to his room. So in case the general have any work, or any briefing, he will bring or call one of his three linguists. If it was really work, I will be more than glad to come. And I did it in my office for emergency "special informations..." But Captain Peterson let me feel that wasn't work at all... And this was the reason I asked Jack to ~~replace~~ me. And they refused. When I was leaving the palace, I saw my respectable boss Colonel Kelly Hodges I asked him about coming back after

Midnight to the palace for the general. I saw his face, he was shocked, he didn't have any idea about it, with his manner, his value, his honor, he asked me to hold one. He went inside, defending me and told me to go to my room with all the respect and the honor. I felt safe that the honorable Colonel Kelly Hodge, not only my boss, and my correct leader, he is a brother who did protect me and defended me when really I needed. He is my ideal and because of his example, I stayed in my job and I still believe in the good U.S Army, which they are the Soldiers of my Country. The general act caused a division in the army at the palace. And on the top, the second day, the general came personally, stood in front of me with six of his Colonel, in my desk "like he is forcing me to do a briefing for him" to cover up. Or to frame me again. I was more than glad to do the briefing for him. But it was a show off in front of everybody. This was the first sexual Harassment

- the Second Harrassement was the second day after the show-off in the morning on my desk. In June 2005, at the palace of Fob courage, after all this. I was leaving my office I hurt somebody (the general telling his linguist the Captain d'origine Egyptian asking him to stop me. We stopped in front of the security. The Captain was telling that I did very good job in the morning briefing while the general took his army hat "the Casquette" smiling to me like I smile to a baby. for almost 20 minutes. I believe that he is waiting for his linguist talking to me. At the end I am leaving the palace, the linguist went up to the general suite, while the general walked with me, putting his hat, shoulder to shoulder for almost two hundred meters till the Kurdish security stood up and say hi to the general. I was really embarrassed, intimidated by his behavior for two days in a row. In my opinion, the general

was thinking that I am going to the chow Hall so we can have a dinner together. Soon as we passed the Kurdish Security at the palace, I was running. Scarrying why the general is doing that? without turning my back I was running to my room, I cried the whole night guessing the behavior of the general. I didn't like it. I was really scared and frighten from him. And I was right, look what happened to me after I came from Iraq till now. How much prices I paid for almost five years. the false file he ordered, my life is in danger. Why?? he damaged, ruined my life, destroyed my name, my credit, controlled my life because I didn't come to his room after midnight at 12:30 am. Nobody above the law or the Constitution of the U.S.A. He is the one should protected me and my rights as a U.S. citizen. No Ammunity for this kind of Behavior <sup>from</sup> a general or a <sup>major</sup> sergeant should be

- the most dirty person on earth you can ever meet. She is SAMANTHA A shoden ILT, MI, special security officer. at the Headquarters, 11<sup>th</sup> Armor Cavalry Regiment she was the POC of the office of C2X. she did tried to Harrassed me Sexualment to many times. 2 to 3 times daily at least, she used to tell me in the office during my duty that I am an old fashion and if she is in my place, she will make Love between 7 to nine men a week, in front of the other members of the Army. She was a double agent between the leaders, she is a troublemaker, dating a married civilian person named Tony Moubasat. She was gossiping badly about her leaders in the Army. She was a Complicated person and her excuse was that she was adopted. she is the One who hang my picture in the office wall but the Same time, she was setting me up. One evening in July, 2005

she committed a Sexual Harassment during my job, in my office at C2X, while Captain Moriss was watching and enforced this Conspiracy more than an hour. SAMANTHA A shoden called herself my boss, and it is an order, tried to force me to say to her married boyfriend Tony Moubasat "I Love you" which I refused, she wont let me defended myself when her boyfriend stand in my back and his face was 5 centimeters from my right shoulder. When I carried the ruler, she was yelling at me that I can't defended myself. She is my boss to put my ruler down. Everybody was watching this show from Captain Moriss who seems enjoying this show, 2 linguist Roy and EDDY. they insisted Tony and his girlfriend LT Samantha, to tell Tony same word, I refused to tell him "I Love you". She was laughing and her married boyfriend Tony didn't moved from the top of my shoulder. Because I am a polite woman I tried to convince him that

he is like a brother, but he was still very very close, on the top of my shoulder. So I decided as a good behavior woman, if he touch me, I will defend myself with the ruler in front of me. When I touched the ruler, this dirty Lieutenant Samantha A. shoden yelled on me and she is my boss I should listen to her and I can't defend myself against her boyfriend and to put back my ruler and this is an order. She was laughing like a drunk person and everybody was laughing too. I was shocked seeing Captain Morris smiling without stopping them and having them Harrassing me. For almost one hour, after that humiliation and the insulting that any good or normal human being can feel it by force. You dont believe what my embarrassing and insulting feeling I had and I felt it. After all of that, this ILT, Samantha tried to force me to dance with her married boyfriend Tony Moubaset in Frank Sinatra

Song "Strangers in the night". I refused in front of everybody, she insisted that it is an order and she is my boss. My answer to her was to dance with Tony because he is your friend. She knew that I had enough and that I am gonna start talking about her relationship with Tony which I knew from both of them. And this is illegal relationship because he is a married man. Another friend of her and the linguist for Captain Moriss and in front of him, named EDDIE, tried to touch me and pulled my shirt and singing to me "O beautiful, O beautiful." I defended myself while Ex-colonel in the army named Mary, tried to give me her army belt. When she saw me defending myself, Mary told me "I am proud of you". Captain Moriss was standing next to EDDIE, was smiling without trying to stop him. Where is the discipline of the uniform. This evening the office of C2X was like a room in the play boy.
