- 1. Reference (a) announced I had been selected for promotion during the FY10 Lieutenant Colonel Promotion Selection Board with selection #302. Reference (b) projected my promotion to occur on 1 July 2010.
- 2. On 17 June 2009, I was detained and questioned by NCIS under suspicion of having committed misconduct. Subsequent legal proceedings dragged on for over two years. CMC(JAM) published reference (c), and delayed my promotion to Lieutenant Colonel.
- 3. The Commanding General, I MEF concluded the allegations of misconduct against me are unsubstantiated; and, he has directed that this case be closed (enclosure (1)).
- 4. Reference (d) informed me that my promotion case is pending a determination of whether I am morally and professionally qualified for promotion. The following sub-paragraphs cite information, which is documented within reference (e) and communicates my moral and professional qualifications for promotion:
- a. My inclusion amongst those officers named in reference (a) implies that my qualifications and performance of duty clearly demonstrate that I am capable of performing the duties associated with the next higher grade (reference (f)).
- b. Over twenty-nine (29) months had transpired between the publication of reference (a) and my receipt of reference (d).

Subj: REQUEST FOR REMOVAL OF PROMOTION DELAY AND DATE-OF-RANK ESTABLISHED AS 1 JULY 2010

Since the publication of reference (a) in 2009, I have remained:

(1) Morally qualified for promotion. DoNCAF completed an inquiry into my loyalty, character, trustworthiness, and reliability, required for access to national security information. On 7 September 2011, DoNCAF determined that I continue to be eligible for a TS/SCI security clearance.

(2) Professionally qualified for promotion

- (a) Following my detention by the NCIS, I was reassigned from my billet as the Operations Officer within I MEF Command Element G3 Current Operations Section to the I MEF Headquarters Group (I MHG), and considered non-deployable. Within I MHG, I served consecutively within two, principle staff officer assignments; both of which were outside of my primary military occupational specialty (PMOS) and designated for a Lieutenant Colonel. As indicated by the reporting senior (RS) and reviewing officer (RO) relative values of my fitness reports, I have continued to consistently perform above average, (reference (e); specifically, my Master Brief Sheet).
- (b) On 16 November 2011, I qualified with the M9 Service Pistol (Expert, 8th Award).
- (c) On 17 November 2011, I conducted the Combat Fitness Test (256, 2nd Class).
- (d) <u>USMC Height/Weight standards</u>. I am 70" in height; and, I weigh 1741bs. My physical appearance is depicted by a current photograph within reference (e).

5. I respectfully request:

- a. the promotion delay be removed, thereby affecting my promotion to the grade of Lieutenant Colonel, in accordance with reference (a); and,
- b. my date-of-rank be established as 1 July 2010, in accordance with reference (b).
