AGREEMENT FOR LEGAL SERVICES

CLIENT: MRS. SIATAN KAMAL

MATTER: Representation for Legal Services Regarding Filing a Grievance Concerning Placement on Nonduty Status and Informal EEO Complaint

- 1. The Law Firm of Puckett & Faraj, P.C. ("The Firm"), agrees to provide the following legal services to Mrs. Siatan Kamal ("Client") 1) filing a grievance concerning placement on Nonduty Status and informal EEO complaint against the U.S. Public Health Service (Agency). Representation shall terminate upon completion of the above described representation or upon agreement between Client and The Firm. The Client understands that no particular attorney of The Firm is being retained, but rather The Firm is undertaking legal representation of the Client according to this agreement. The Firm reserves the right to assign and delegate all aspects of such representation as The Firm deems appropriate. - a. Other expenses or costs including items such as, but not limited to: office meetings, telephone calls, emails and faxes, either to or from Client or on Client's behalf related to representation of Client, investigative services or experts, any required travel, transportation and lodging, printing and photocopying, postage, phone calls and faxes, transcription services and electronic legal research fees. Any attorney traveling overseas in support of a Client will be via business class airfare on a carrier of the Firm's choosing. Client agrees to pay for business class airfare in advance of travel. Client further understands and agrees that the fees will be earned at the following rates:
- 1. An Attorney hourly fee of \$275 for all attorney time spent on consulting, any research and analysis; development or review of correspondence; negotiating, advising or counseling to the Client;
 - 2. Any services by researchers or paralegals at a cost of \$100 per hour;
 - 3. All costs, fees or other charges actually paid or incurred by The Firm.
- b. If The Firm is released prior to the final disposition of the case, you further agree that the fees shall be earned for all work accomplished to that agreed upon date, as assessed by the attorneys.

- c. The Attorney-Client relationship and any work on Client's case will begin when The Firm has received a signed copy of this Agreement and the Fee advance of \$3500.00. If payment is made by check, work will not begin until the check "clears," (payment is made on the check by Client's bank).
- Client understands and agrees that all fees are deemed the property of The Firm upon receipt and will deposited or transferred immediately into The Firm's operating account. The Firm will provide the Client with an accounting in the form of invoices of fees and expenses and other costs. Upon termination of representation, The Firm will refund to the Client the amount of any fee advance that has not been earned as of that time. - The Firm may withdraw from representation in this matter if you: insist upon 6. presenting a claim or defense that is not warranted under existing law and cannot be supported by good faith argument for an extension, modification, or reversal of existing law; personally seek to pursue an illegal course of conduct; insist that The Firm pursue a course of conduct that is illegal or that is prohibited under the disciplinary rules; render it unreasonably difficult for The Firm to carry out its employment; insist that an Attorney engage in conduct that is contrary to his or her judgment but not prohibited under the disciplinary rules; or deliberately disregard any agreement or obligation to The Firm as to the timely payment of expenses or fees as required by this agreement for services rendered. The Firm will also have the right to withdraw from the case if you fail to make the payments required by this agreement or if you misrepresent or fail to follow my advice. - 12. If it is necessary to cause suit to be filed for collection of any sums due to The Firm from you under this agreement, you shall pay the reasonable attorneys fees together with Court costs for collection.
- 13. If the foregoing terms are acceptable, please sign and return one copy of this letter. I look forward to working with you.
