The BOI hearing shall be held at the Marine Corps Air Ground Combat Center, Twentynine Palms, California. The physical location is the Joint Law Center courtroom (Bldg. 1515) or as otherwise directed. The BOI is scheduled for 31 Mar 11 - 1 Apr 11. Per reference (b), any continuance requests will be forwarded to the convening authority for approval. The hearing is anticipated to take no more than two days. The uniform will be the uniform of the day.

- 1. Pursuant to paragraph 13d of reference (a) and paragraph 4006 of reference (b), I have been designated as a Show Cause Authority for the Marine Corps. In that capacity, I have reviewed the allegations of misconduct and substandard performance of duty in reference (c) and have determined that there is sufficient information to refer this case to a Board of Inquiry for a recommendation as to whether Major Scarselli should be retained in the Marine Corps.
- 2. Accordingly, you are directed to convene a Board of Inquiry under the provisions of reference (a) to consider Major Scarselli's case. The specific reasons for separation to be considered by the Board are substandard performance of duty and misconduct, or moral or professional dereliction as evidenced by one or more of the following:
- a. Substandard performance of duties, as evidenced by a failure to demonstrate acceptable qualities of leadership required of an officer of the member's grade; and
- b. Misconduct or Moral or Professional Dereliction, as evidenced by the commission of a military or civilian offense which could be punished by confinement of 6 months or more.
- 3. You are directed to notify Major Scarselli by separate correspondence that separation proceedings have been initiated.

- 4. The written report of the Board of Inquiry will be forwarded to the Staff Judge Advocate, Marine Corps Combat Development Command via the Staff Judge Advocate, Training and Education Command.
- 5. Correspondence relating to this and all other officer administrative separation proceedings should be mailed using Federal Express. Use of the U.S. Postal Service will result in undue delay to mandatory offsite irradiation.
- 6. Reference (b) provides time goals for processing officer administrative separation cases. Failure to comply with those standards should be addressed in the return endorsement.
