Good morning.

In response to the question regarding Language Proficiency, please refer to Exhibit H of the RFP, p 51-3 of Exhibits section. Several speaking levels (0-3) are described. In short,

Speaking Level 0 (No proficiency) - "Unable to function in the spoken language."

Speaking Level 1 (Elementary proficiency) – "Able to satisfy minimum courtesy requirements and maintain very simple face-to-face conversations on familiar topics." (Examples are provided)

Speaking Level 2 (Limited Working proficiency) – "Able to satisfy routine social demands and limited work requirements." (Examples provided)

Speaking Level 3 (General Professional Proficiency) – "Able to speak the language with sufficient structural accuracy and vocabulary to participate effectively in most formal and informal conversations on practical, social, and professional topics." (Examples provided)

In MVM's Technical Proposal (page 3-39), we outline what speaking levels will be required for TCNs and LNs, as demonstrated on verbal and written language exams. TCNs will have a Level 2 proficiency; LNs serving as Interpreters will have a Level 2 proficiency as well (in our proposal we state that LNs serving as Guards will have a Level 1 proficiency, but in the Amendments, this is now one position — Guard/Interpreter. Need some clarification on which Level LNs need to be — all Level 2s?) All US positions require Level 3 proficiency.

I am looking at time lines this weekend. My best guess at this point is the process is in two parts 1) a Bio/Resume (2 pages) sent to DOS via MVM which they review and basically say the candidate meets the basic requirements, i.e. military, etc. This takes no more then a couple of days and 2) once we get the green light to go from step one we/you prepare/submit the clearance package. They believe this will take 30 to 45 days.
