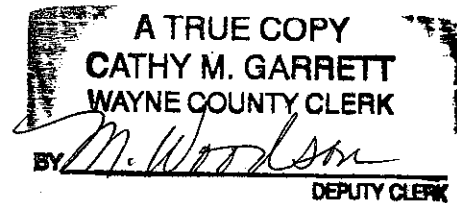
This Order resolves the last pending claim and closes the case.
