- (4) That Major Scarselli questioned Staff Sergeant Baker about his interview with the Command Inspector General after receiving his direct order from Colonel Green to not interfere.
- (5) That the preponderance of evidence supports a finding of substantiated.

ax. Recommendations.

- (1) That Major Scarselli be immediately removed from his billet as the Provost Marshal, removed from the Provost Marshal Office, Marine Air Ground Task Force Training Command, Marine Corps Air Ground Combat Center.
- (2) That Major Scarselli be charged with violations under Article 92, Article 107, Article 133, and Article 134 of the UCMJ.
- (3) That Master Gunnery Sergeant Humbertson be immediately removed from his billet as the Provost Sergeant, removed from the Provost Marshal Office, Marine Air Ground Task Force Training Command, Marine Corps Air Ground Combat Center.
- (4) That Master Gunnery Sergeant Humbertson be charged with violations under Article 92, Article 107, and Article 134 of the UCMJ.
- (5) That Staff Sergeant Brookins be immediately removed from the Provost Marshal Office, Marine Air Ground Task Force Training Command, Marine Corps Air Ground Combat Center and charged with violations under Article 92 of the UCMJ.
- (6) That Staff Sergeant Puente be immediately removed from the Provost Marshal Office, Marine Air Ground Task Force Training Command, Marine Corps Air Ground Combat Center and charged with violations under Article 92 of the UCMJ.
- (7) That Sergeant Rusnak be removed from the Provost Marshal Office, Marine Air Ground Task Force Training Command, Marine Corps Air Ground Combat Center and charged with a violation under Article 92 of the UCMJ.
- (8) That Sergeant Wells be removed from the Provost Marshal Office, Marine Air Ground Task Force Training Command, Marine Corps Air Ground Combat Center and charged with a violation under Article 92 of the UCMJ.
- (9) That Lieutenant Daly, Civilian Police Officer, be immediately removed from the Provost Marshal Office, Marine Air Ground Task Force Training Command, Marine Corps Air Ground Combat Center and appropriately disciplined up to and including termination for falsifying an Official Civilian Payroll Time Sheet, a violation of DoD 7000.14-R, while in a probationary employee status.
- (10) That Staff Sergeant Baker be charged with violations under Article 92 of the UCMJ.

- (11) That Staff Sergeant Baker fully cooperated with the Command Inspector General, and the Criminal Investigation Division, without any promises made, or requested by him. His cooperation was critical in providing evidence responsible for substantiating the allegations against Major Scarselli and Master Gunnery Sergeant Humbertson and is offered for extenuation and mitigation.
- (12) That the Directing Authority accept the findings of fact, analysis, and recommendations contained in this report.
- (13) That the Directory Authority direct this case to be closed.
- (14) That the Directory Authority direct a copy of the report be forwarded to the Commanding Officer, Headquarters Battalion, Marine Air Ground Task Force Training Command, Marine Corps Air Ground Combat Center.
