Market Trends & Drivers

- Government contracts for translation/language services are on the rise.
- Federal spending on language contracts increased from nearly \$14.9 million in 1990 to more than \$1 billion in 2009. FY2010 data is not fully reported yet.
- Between FY2007 and FY2008, translation/language services spending has more than doubled.
 - This could be due to heavier infuses on agencies to procure outside of schedules (see slide 4 vs. slide 8)
- An increase in spending for translation/language services can also be a result of the heavy enforcement of Title VI of the 1964 Civil Rights Act, which prohibits discrimination in federally funded programs.
 - This means agencies are relying more on language contracts to translate documents and serve as interpreters.
- The increasing immigrant populations have created a civilian need for language services.

Market Trends & Drivers (Continued)

- Translation services contracts often are more cost-effective than establishing in-house language programs, causing an increase in federal spending on these services.
- President's programs for foreign trade, diplomacy and domestic multiculturalism urge the federal government increasingly cause needs for translation/language services.


- The following slides include data pulled from the Federal Procurement Data System (FPDS) for the related NAICS Codes and Product Service Code (PSC) as follows:
 - R608 Translation and Interpreting Services (Including Sign Language)

OR:

- ❖ NAICS: 541930 Translation and Interpretation Services
- NAICS: 611630 Language Schools
- Consequently, these totals only account for prime contract spending where the reported PSC/NAICS pertains directly to Interpretation/Language Services. They do not include Interpretation/Language Service activities that may be rolled up under prime contracts with a broader scope.
- While these following slides should not be considered a comprehensive view of the U.S. government market for Interpretation Services, it should serve as a good indicator of the overall market direction






Top 10 Prime Contractors by Share (\$000)
