Certification Regarding Compliance with Anti-Bribery Laws

<u>Arrow General Supplies Corporation</u>, which is entering into a business relationship with 3D Global Solutions, Inc. or its affiliates (hereinafter "3D Global Solutions"), hereby, as appropriate, represents warrants, affirms and agrees that:

- 1. None of the principals, officers or employees of <u>Arrow General Supplies Corporation</u> is a government official, an official of any public international organization, a political party official, or a candidate for political office.
- 2. All of the information that <u>Arrow General Supplies Corporation</u> has provided to 3D Global Solutions and its representatives in connection with 3D Global Solutions retention of <u>Arrow General Supplies Corporation</u> was and remains current, accurate and complete.
- 3. <u>Arrow General Supplies Corporation</u> will obtain written approval from 3D Global Solutions, Inc. before <u>Arrow General Supplies Corporation</u> hires subagents, and that no subagent will be approved unless that subagent agrees in writing to these same terms and conditions.
- 4. In connection with its representation and work on behalf of , 3D Global Solutions Inc.

 <u>Arrow General Supplies Corporation</u> shall not give, offer or promise to give, or authorize the giving directly or indirectly through any other person or firm, of any money or thing of



value to any employee or official of any government, employee or official of any public international organization, any political party or official or employee of such party, or any candidate for political office, for the purpose of inducing or rewarding favorable action or the exercise of influence by such official, party or candidate in any governmental matter.

- 5. In connection with its representation and work on behalf of 3D Global Solutions, Inc. Arrow General Supplies Corporation shall not give, offer or promise to give, or authorize the giving directly or indirectly through any person or firm, of any money or thing of value to any foreign party or its representative as an inducement or reward for the party or representative doing or forbearing to do any act in relation to the business or affairs of 3D Global Solutions, Inc. or Arrow General Supplies Corporation , or for showing or forbearing to show favor or disfavor to any person in relation to the business or affairs of 3D Global Solutions, Inc. or Arrow General Supplies Corporation .
- 6. <u>Arrow General Supplies Corporation</u> will provide documents and information to 3D Global Solutions, Inc. upon request, confirming <u>Arrow General Supplies Corporation</u>'s compliance with this agreement, and will allow 3D Global Solutions, Inc. (or its agents) to review <u>Arrow General Supplies Corporation</u>'s books and records with respect to the work performed on behalf of 3D Global Solutions, Inc. at any time.
- 7. If there are any additional owners in, or change in the ownership of, <u>Arrow General Supplies Corporation</u>: Arrow General Supplies Corporation shall notify 3D Global Solutions, Inc. of the identity of the new owner(s) as soon as possible. 3D Global Solutions, Inc. may terminate its agreements with <u>Arrow General Supplies Corporation</u>. if 3D Global Solutions, Inc. disapproves of such new owners. [This clause does not apply to Agents/Representatives who are natural persons. For Agents/Representatives that are publicly traded companies, this clause would apply only in the event a new owner or group of owners should acquire 5% or more of the Agent Company.]



8. This certification is being provided to 3D Global Solutions, Inc. in connection with 3G Global Solutions, Inc.'s decision to enter or continue a business relationship with <u>Arrow General Supplies Corporation</u> violates any of the terms of this agreement, 3D Global Solutions, Inc. shall have the option to terminate its contract with <u>Arrow General Supplies Corporation</u>, notwithstanding any other provision of 3D Global Solutions, Inc. contract with <u>Arrow General Supplies Corporation</u> to the contrary. Moreover, <u>Arrow General Supplies Corporation</u> shall forfeit any commissions owed to it by 3D Global Solutions, Inc. upon an admission or finding that <u>Arrow General Supplies Corporation</u> has failed to comply with any of the terms of this Certification.
