


Focus on Biotechnology


2011 brought our companies a large number of biotechnology matters in practice areas such as patent infringement, employment, and securities. Some highlights:

Patent Infringement

Military Trial Updates

Legal Arts principal Jim Gripp was appointed by the convening authority as an expert in crime scene reconstruction and 3D-computer animation for the defense in two cases:



U.S. Army SGT Joseph Bozicevich, attached to the Third Infantry Division, was tried for capital murder of two fellow NCOs at Patrol Base Jurf in Jurf as Sahkr, Iraq. Sgt. Bozicevich

was represented by civilian counsel Charles W. Gittins of Middletown, VA, in addition to military counsel at Fort Stewart, GA. In May 2011, he was convicted of pre-meditated murder, but not by a unanimous jury vote, which eliminated the death penalty option for sentencing (scheduled for mid-August 2011).



At Camp Pendleton, CA, the trial of U.S. Marine Corps SSG Frank Wuterich of Kilo Company, 3rd Battalion, 1st Marines is scheduled for late 2011. He is represented by Neal

A. Puckett and Haytham Faraj of Puckett & Faraj, PC of Alexandria, VA, in addition to military counsel.

Legal Arts has acquired three new photogrammetry tools to assist our clients in obtaining accurate dimensioning from photographs. Apart from our standard hourly rates, there is no extra charge for these services.



PhotoModeler is a professionalgrade photographic analysis application that gives us the ability to scale dimensions from scene documenta-PhotoModeler tion photos. This tool has helped us to

accurately scale physical evidence from crime scene photographs taken in Iraq.

Pictometry is one of two photography analysis applications we licensed to help us to dimension objects and perform area calculations di-




rectly from orthographic and oblique Bing and proprietary **Pictometry** aerial photos.



Google Earth Pro is similar in concept to Pictometry, allowing us to perform dimension and area calcs from higher than normal Google Earth photos. We've used both of these applications

to calculate the sizes of areas properties subject to litigation burned in the 2007 Witch Creek and Guejito wildfires.


Did you know that commercial use and enlargement printing of Google Earth images requires a Pro license? Keep that in mind next time you order blowups.
