it twice a day, but he keeps forgetting to take the second dose, so was initially elevated 201/100, improved to 184/90, but it went back up 190/100. We did give him some Percocet 1 tablet p.o. to help with his pain. I did give him a clonidine 0.1 mg p.o. With that, blood pressure improved to 162/89. I had long extensive discussion about the blood pressure pill, he much prefers to use pills taken once a day and was much better in that, so with this I put him 10 mg of Benazepril as well as 25 mg of hydrochlorothiazide to take once a day to see if he can better control. We will stop his enalapril. Will follow up with PMD later this week for recheck of his blood pressure. The patient given blood pressure instruction sheet as well as back pain and the sprain instructions, was discharged home to use some Vicodin p.r.n. for pain, cold packs, rest, continue to monitor blood pressure. Discharged in good condition.
