
### II. CHARGES AND SPECIFICATIONS

10. **Additional Charge:** Violation of the UCMJ, Article 90

Specification 1: In that Gunnery Sergeant Marcus S. Bell, U.S. Marine Corps, Headquarters and Headquarters Squadron, Marine Corps Air Station Miramar, California, on active duty, having received a lawful command from Lieutenant Colonel Charles A. Redden, U.S. Marine Corps, his superior commissioned officer, then known by the said Gunnery Sergeant Bell to be his superior commissioned officer, to restrain from initiating any contact or communication with Mrs. Tyquanta R. Bell or words to that effect, pursuant to a Military Protective Order issued on 15 August 2010, did, at or near San Diego, California, on divers occasions from on or about 20 August 2010 through on or about 2 September 2010, willfully disobey the same.

Specification 2: In that Gunnery Sergeant Marcus S. Bell, U.S. Marine Corps, Headquarters and Headquarters Squadron, Marine Corps Air Station Miramar, California, on active duty, having received a lawful command from Lieutenant Colonel Stephen M. Griffiths, U.S. Marine Corps, his superior commissioned officer, then known by the said Gunnery Sergeant Bell to be his superior commissioned officer, to restrain from initiating any contact or communication with Mrs. Tyquanta R. Bell or words to that effect, pursuant to a Military Protective Order issued on 3 September 2010, did, at or near San Diego, California, on divers occasions from on or about 3 September 2010 through on or about 14 October 2010, willfully disobey the same.
