

Attached you will find the instructions for collecting hair for toxicology testing. We will need a very substantial thickness of hair, as we will only be interested in the hair growth during the time of your incident(s), which will be several inches down the length of the hair, and the hair growth further out will be rather thin compared to that at the root end.

As I mentioned to you today, our method is not yet complete, but we hope to be validated and ready to go on casework before your anticipated May 2009 trial date. We are also working on a method for GHB in hair, so if that is ready for casework before your deadline, we can talk about testing the hair for GHB as well.

I will also need information about any drugs your victims may have taken the month before and the month after the incident(s) in question. You may want to ask them if they had any surgery during that time period or dental work, to help jog their memories. You may find it easier just to get their medical records.

We will also gladly test your victim's vomit-stained shoes if they are still around.
