1. Staff Sergeant Wuterich, through his defense counsel, has requested you defer his reduction in rank until such time as you take Convening Authority's action. You are authorized to grant such a deferment under reference (b).

2. In accordance with the references, you, as the convening authority may defer the accused's service of a sentence to confinement, forfeitures, or reduction in grade that has not been ordered executed. Reference (b) lists factors that the convening authority may consider. These include: the probability of the accused's flight; the probability of the accused's commission of other offenses; intimidation of witnesses, or interference with the administration of justice; the nature of the offenses (including the effect on the victim) of which the accused was convicted; the sentence adjudged; the command's immediate need for the accused; the effect of deferment on good order and discipline in the command; and the accused's character, mental condition, family situation, and service record.

3. You are the final authority for this request and your decision on this matter is final, subject only to judicial review for abuse of discretion.
