This information will be made available to trial and defense counsel before trial so that they may have general information about a member's background before assembly of the court and is also available to the military judge. Disclosure of this information is voluntary. Nondisclosure may require a member to provide such matters at trial. By requesting this information on a one-time basis before you actually serve as a member, repetitive questions and unnecessary delay can be avoided. Your responses should be forwarded to the Office of the Staff Judge Advocate, ATTN: Chief, Criminal Law Division.


