Thank you for your recent payment on November 4, 2010, of \$100.00. The balance on your account is \$11,375.00.

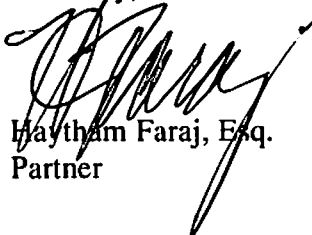
