I, Mrs. CHAJI, want to make the following statement under oath.

MONDAY: On Monday 16 Aug 10, Gary and his wife, Zahra, were fighting at their house. Gary called me and asked me to come over. I went over there and saw Zahra was locked in her room. Zahra was saying he wanted to kill her through the door. I was talking to her through the door when she opened the door and ran downstairs. She tried to get her keys and cell phone but Gary took it away from her and she ran to the neighbor's house who called the MPs. She told them Gary hit her, dropped her onto the floor, and tried to choke her. They arrived and the ambulance took her to the ER. The ISG asked me to go with her so I took my kids and went with her. I stayed there until 2100 and went home because my kids have to be in bed. Gary called me all night asking me what was going on with Zahra. Later that night, Gary came back he told me he needed to go to his house to pick up some of his stuff. Zahra called me and asked me to get her keys from Gary. When Gary got there, he was with a black man, his NCO. His NCO and I stayed outside while Gary grabbed his clothes and came to my house crying and we talked. He left his stuff at my house that night. He had Zahra's keys to the house and gave them to me and left.

TUESDAY: Gary came over around 0730 but was texting me before he came over. He told me he would take my kids to school and you can talk to Zahra at the hospital but I called her instead. About 1100-1200, Gary called me crying and told me he didn't trust Zahra. I didn't say anything to him, I just listened. It was none of my business. He told me he would blow up if she tried to divorce him. Gary texted me and asked me to forward the text to Zahra. I think the text said he didn't have anybody and couldn't stand life without of her. I told Gary that if she loved him, she would go back to him. That night, he came over and asked me money for cigarettes. I told him Zahra was coming over to eat breakfast and he had to leave. He told me he was hungry and had nowhere to go. I walked over to Zahra's house and told her Gary was over my house and was asking for something to eat. She told me to let him stay which I did. I went home and fed him and he began to cry and started his story all over again about him having nothing. I just wanted to be left alone and didn't want to be in the middle of this. I asked him to leave, which he did.

WEDNESDAY: I went to school 1230, and throughout the day, Gary was texting me that he had nowhere to go. Gary and Zahra were texting me and calling me to ask how each other were doing. That night at about 1830, I went to Zahra's house to grab some things out of her house. I noticed Zahra was changing her clothes and told me a friend was going to pick her up. I looked outside and saw Gary at my house. I went home and I didn't want Gary to see Zahra get picked up by someone because he might get jealous. I remember I brought him inside and placed my keys at the table by the front door. He did see Zahra get picked up anyways and became pissed off. He said all women were alike like his mother. He said his mother was a whore like his wife. He called Zahra with my phone and asked her where she was. She told him it was none of his business and I heard this because he put my phone on speaker. He said if she was going to divorce him, he will get mad. He got mad so I asked him to leave. He asked me for some money for cigarettes and I gave him some and asked him to leave. I didn't walk him to the front door but when I returned to lock the front door, I noticed my car was gone. Gary came driving back to my house with my car and he came up to my door. I asked him to give me the keys to my houses and car and told him to never take my car again. I asked him if he followed Zahra because he left the same time Zahra got picked up but he said no, he didn't follow her. He started screaming and getting mad. I called his friend Jackson and I told her if she could help them to be together and she called me back. I told her I didn't want to be involved anymore. I asked to leave and I went upstairs to put my kids to bed. When I came down, he was in my house, sitting on the sofa in the dining room. I asked him what he was doing, and he said he wanted to talk. He started screaming again and then told me my husband cheated on me and Zahra cheated on him so we should do something. He wanted to be together. I told him to stop talking bullshit and all this crazy things. I remember Zahra called me and I told her Gary was here. I told him he had to leave when he told me he wanted to kiss me and I stood up. I told him to leave but he stood up and pushed me back down onto the couch where he pulled his penis out and told

me I had to do what his wife did to him. I said no and he grabbed a picture frame on the kitchen counter and placed it on the left side of my neck. He told me he will kill me if I didn't do what he wanted. I pushed him away and went upstairs where he followed me upstairs. He came inside my room and closed the door. He had a knife in his hand and told me he was going to do what he wanted with me. He told me if I didn't get naked, the knife will be in my body. He then turned off the lights and raped me. When he got done, he wiped himself with blue pajamas that belong to me and threw the PJs in my face. He said, "all you womans are the same; you are bitches and that's the way I have to treat the womans". He told me if I told anyone, he will kill me. He went downstairs and I saw the knife on the floor in between my bed and dresser. I changed my clothes and went downstairs where he told me he could do whatever he wanted and if I told anyone, he will kill me. He told me if I told, he will rape my daughter, kill her and shoot my husband in the leg.

TURSADAY: In the morning, Gary tried to call me but I didn't answer the phone. I called him back wanting to know what he wanted and he sounded normal. He came over after and I asked him what he wanted and why he raped me. I told him if he did it again and scare me, I would have called the MPs. He left and that night I called Zahra but I couldn't tell her what happened. I started to cry and she asked me if I was okay. I couldn't tell her though because I was scared. That night, I locked myself into my bedroom with my kids and slept all night.

FRIDAY: On Friday morning, I talked to Zahra, put some clothes on and went to the Mary Walker Clinic (MWC). Before I left, I called Gary once as I stood in front of the front door and the back door to see if I could hear his cell phone. Once I didn't hear anything, I felt safe and left. That's when I passed out at the MWC. I was brought to the ER where I was stayed all night. I remember that night; Zahra came to visit me, alone, and asked me to call Gary. Gary told me he was going to Chahat's house and both, Zahra and Gary told me they were working things out and were getting back together. I was happy with what was going on because I thought Gary would then leave me alone. Gary came to the hospital later that night and I told him he could now forget about me know and I told him were like brother/sister know, right? He said no and wasn't going to leave me alone. He told me if I told anybody, he will kill me. He left and I felt unsafe. I asked the doctor for sleeping medicine and slept all night.

SATURDAY: On Saturday, I woke up, ate, and slept more until 12:30. Zahra came by the hospital to visit when Gary called the hospital phone in my room. I told him I was leaving with Zahra and going home. Heading out the hospital, Zahra told me we needed to go out. I told her I wanted to go home and she drove me in her car to my house. I remember she called Gary and told him she wanted to go out with him on that day. Zahra dropped me off and later, Zahra and Gary came to my door and told me they wanted to talk. They left and told me to change my clothes. They wanted me to go with them into town but I didn't want to go. I told them I was staying. Zahra told me she wanted to take me to the hospital in town to get my head checked out. I ended up going with them. Before I left, I called my babysitter who was watching my children that Zahra and Gary was taking me to the hospital and if she could watch them longer. She told me I should tell Zahra it was none of my business. I remember we were in Zahra's car and she was driving. I was sitting in the passenger front seat and Gary was sitting in the driver back seat. Zahra got a text from one of her NCO's and was asking her to go with him to Las Vegas. Gary got jealous and they were fighting over the phone. I remember we were Costco, the International Store called Basha Market, and Olive Garden in Victorville. While in Victorville, I remember we were sitting outside and Zahra and I were talking. She was telling me I shouldn't trust anyone and was telling me to go. I also remember while inside, Zahra went to the bathroom and Gary told me not to tell her anything or else he will kill me. When we finished at Olive Garden, I called my babysitter to tell her I was coming back home. Gary drove back while Zahra sat in the passenger front seat and I sat in the driver back seat. While coming back, Gary was telling me how he could get my husband in trouble and I started to feel sick. I felt like I was going to throw up. I asked them to take me to the hospital but both of them told me they couldn't because they weren't suppose to be together and their commanders would find out if they brought me to the hospital. When we got to the gate, I started to open the door because I thought I was going to throw up. I remember the gate guards asked us to pull over while they checked our IDs. Gary pulled over and waited. I remember thinking I was going to throw up and opened the door when the guards

brought our IDs back and we went home. I went inside my house while Gary and Zahra put some stuff I bought at the market inside my house. I told Zahra I was going to the hospital but she told me not to because they would have asked what I ate that day to make me sick. She said I was supposed to rest and they would ask what I was doing and she didn't want me to tell them Zahra and Gary was together. When Tracy left, I drove to the hospital and felt really dizzy. Two guys there helped me and I stayed there until about 0140. Gary showed up at the hospital. I guess Gary asked the nurse to see me and at first I said no but then I was worried he might have harmed my children. I okayed him and he came inside, closed the door, and told me why I came to the hospital. He thought I was there to tell the hospital what he did to me. I told him I didn't say anything and I wasn't going to tell. He told me to give him my car keys but I refused and he took them from me and left. The doctor came inside and asked me if I was ready for my exam but I just wanted to leave. I discharged myself and went outside where Gary was standing next to my car. I asked him for my keys and he gave them to me and followed me home. I remember I parked my car in a trailer lot behind my house but I didn't think about why I parked there. I just did and went into my house from the back. Gary followed me into my house and we talked. I told him to go back to his wife and I swore to him that I wouldn't tell anybody. I told him if he didn't leave me alone, I would have told somebody. He told me he was trained in by the Army and knew not to leave evidence. He left my house and I went upstairs to cry in my bedroom. I remember my husband called several times and Gary called me at the same time as I was talking to him. I didn't answer the phone to Gary but then I called him back and he said he was at the front door and to open the door. I said no and he came inside my room. I remember locking the front door so I don't know how he got in. I asked him how he got inside and he said he came through the back door and not to ask him anymore. He said he could go anywhere he wanted too. I told him to do whatever he wanted with me and he just grabbed his clothes that he left last week and told me he wasn't going to leave any evidence. He left and I went to sleep.

(I remember before I was checked into the hospital on Friday, I had \$2000 in cash in my purse. When I left the hospital, \$800 was missing. When I went to the hospital on Saturday night, I still had the \$1200 in my purse, which I left in my car because I was feeling too sick to remember it. When Gary was waiting outside my car at the hospital, I think he took \$200 from my purse because I was missing more money and he took the keys from me.)

SUNDAY: I called Zahra in the morning to see if she was okay. She was and I called Gary to see if I could hear his phone ring around my house. I didn't hear anything so I went to Zahra's house. Before I left, I called my babysitter to check on my children. She said they were fine but wanted chicken so I went over to Zahra's house and she answered the door. I went inside and sat on her couch and was crying. She asked me if everything was okay but I heard somebody upstairs. I asked Zahra and she said she spent the night with Gary. Gary called me from upstairs and told me to leave and that he was coming over to my house later. I went back to my house where I grabbed some things from the Post Exchange that I had to return. When I went to my house, I noticed the front door was unlocked. I walked in and headed to the back door to check when I noticed Gary was behind me, inside my home. He checked the entire house to make sure nobody was around and I told him he had to leave. Somebody called him but I don't know who and he told me he was going to take me. I just complied with him because I was scared and gave him the keys. We went to the commissary and bought dog food for a friend's dog that I was watching and some food for my children. While driving he told me that if I told his wife, my life was over. He told me that I better leave Fort Irwin. He said I could have it the easy way or hard way. He asked me to go to Canada and I told him I couldn't leave. I remember Jackson called him and I told him he had to leave loudly for his friend to hear. After we got back home, he left and I drove to Chahiti's house. I told him I was scared and told him what happened. Chahiti told me to call him and ask him to come to my house to talk. Chahiti told me he will sneak in to hear the threats Gary was making. Chahiti told me he was going to go with me to my house but I told him to follow me because I didn't want anybody to see us together. Chahiti told me to leave the back door open for him once I got home. I called Gary and asked him if he could come over and he said he would be there in 20 minutes. I left and went home parking in the trailer lot again. I went to my backyard and saw Gary sitting in the chair in my backyard. I remember the back door was open. We went inside and he sat on my couch in the dining room. I tried to find my phone to call Chahiti to tell him Gary was in my house. He pushed me against the floor and couch next to the TV and used his arm to choke me. He said he could have choked me with his arm and there was no evidence that way. I fought back and he threw me onto

the corner of the couch. He went into the kitchen and grabbed a knife and sat back down where he choked me. He told me if he wanted to kill me he would a id thrusted the knife into the couch. He came over to me and started to clean the knife and told me he was going to put the knife into my left hand to make it look like I was trying to kill him. He told me to go ahead to tell somebody about what happened because there was already drama with me and the BOUZIDI's and nobody would believe me. I managed to call Chahli and was screaming when Gary got up and tried to get out. I grabbed his shirt and told him he wasn't leaving. He ran to the door and left. Chahli came inside a few minutes later and called the MPs.

A: I only know him by Gary. His wife calls him Sal. He is Zahra's husband.

Q: Can you fully identify Zahra?

A: Zahra Jakane. She is my friend.

Q: Can you fully identify Chahli?

A: I don't know his last name. He is a friend of my husband. He is from Morocco.

Q: Do you know who Gary's NCO was?

A: I don't know his name.

Q: What did Gary text you before he came over on Tuesday?

A: You can check my cell phone to see what he said.

Q: Was it normal for Gary to ask to take your kids to school?

A: Yes.

Q: Why did Gary come over on Tuesday morning?

A: He came by to ask me to talk to Zahra at the hospital. That's why he asked to take my kids to school. He didn't let me sleep all night because he was calling so he took them to school and I called her.

Q: From Tuesday, why did Gary not trust Zahra?

A: Because he found a couple pictures of her NCOs with their penis. He notices that she smiles when she is with her NCOs.

Q: Where were these pictures?

A: He said in her email. I didn't see any pictures.

Q: What do you think he meant that he would blow up?

A: He meant to kill her and to kill all women. He said he had a rich uncle who would have helped him.

Q: Did Zahra ever talk to you about divorcing Gary?

A: Yeah, she talked about that with everybody. She went to JAG to sign the paperwork.

Q: From Tuesday, why did Gary text you and ask you to forward the message to Zahra?

A: Because he knew we were friends and asked me a favor. I didn't send the text.

Q: Was it usual for Gary to ask you for money?

A: No.

Q: Why did he ask you for money?

A: Because he said he didn't have money for cigarettes, money, or his car.

Q: Did Zahra ever know if Gary was at your house?

A: Yes because his car was there.
Q: What does his car look like?
A: Yellow. Camero. Like a sports car.
Q: Did you ever talk to Zahra about what Gary was saying on Tuesday?
A: No. I didn't tell her anything he was saying about her. It was none of my business and I know when someone is mad, they can say anything. I wanted them to get back together.
Q: Where were your children on Tuesday?
A: At school and came back home at about 0130 and 1245. I have two children.
Q: Where did you go to school on Wednesday?
A: College Barstow on post.
Q: What was Gary texting you throughout the day?
A: He said he wanted to come over and he didn't have a place to go. He called me a couple times but I didn't answer.
Q: What was Zahra texting you?
A: Just check the phone.
Q: What did you grab out of Zahra's house on Wednesday?
A: I have some of her pots and I brought them back to her.
Q: Do you know who picked up Zahra or where she went?
A: This was not my business. She told me she went to eat break feast with Mark at Chahji's house.
Q: Where was Gary's car parked when he came over on Wednesday?
A: It was not in front of the house; I don't know.
Q: Did you see Zahra Wednesday night?
A: I talked to her on the phone.
Q: What time?
A: When she came back. I don't remember.
Q: Did Zahra come to your house on Wednesday night?
A: No.
Q: Can you fully identify Jackson?
A: A lady who works with my husband and Zahra. I watch her baby sometimes.
Q: What is your husband's name?
A: Khalid.
Q: Why did Gary tell you your husband cheated on you?
A: When he asked me to kiss him. I said no and that I love my husband. He told me I should have heard around what Zahra said about my husband and they didn't tell me because they didn't want to break my heart. I remember Zahra joking around saying Gary wanted to look at my boobs.
Q: What was Gary wearing when he was at your house on Wednesday night?
A: Uniform
Q: What time did you put your children to bed?
A: Normally I put them to bed at 1930. That night, Gary was there and I put them to bed at around 2030.
Q: Did they come downstairs when Gary was back into your house after you put them to bed?
A: Yes, my daughter came downstairs and I put her back to sleep.

A: I don't know because I didn't check the doors.
Q: Did Gary have a key to your house?
A: I never gave him a key.

Q: Where do your children sleep?

A: Their rooms.

Q: Was the door to your children's room open or closed when you put them to sleep?

A: Open

Q: Do you normally put them to sleep at night?

A: Normally at the same time but not that night.

Q: You have a TV in the dining room, right?

A: Yes.

Q: If the TV was on in the dining room, could you hear it from upstairs?

A: I never paid attention.

Q: When you came downstairs after you put your children to sleep, where was Gary sitting?

A: Sitting in the sofa in the dining room under the window.

Q: Which window?

A: There is only one window.

Q: What did you do when you saw him?

A: Surprised. I asked him how he came inside.

Q: What were you wearing at this time?

A: I was wearing my pajamas.

Q: Can you describe what they looked like?

A: They had linker bell design.

Q: What was Gary wearing?

A: Uniform.

Q: How did Gary pull his penis out?

A: When he stood out. I put my head down and don't remember nothing. I hear his belt open. I didn't look at him. I was trying to put his belt back on but I was scared and put my head down.

Q: Did you see him pull his penis out?

A: He asked me to open my eyes and he pulled his penis out.

Q: Did Gary have an erection?

A: I can't remember.

Q: Can you describe what you saw?

A: I can't remember.

Q: Did Gary have any distinguishing marks that you could identify?

A: I can't remember.

Q: Where were you sitting when Gary pulled his penis out?

A: When my daughter came downstairs and I brought her upstairs and came back down, Gary moved to where the puncture in the couch was. I sat down over where he was originally sitting and the TV was on. I got up to turn the TV off and he pushed me back into the couch and grabbed the picture frame.

Q: What hand did Gary grab the picture frame with?

A: Right hand.

Q: Do you remember what the picture frame looked like?

A: One of the one you guys took.

Q: Has Gary ever touched or picked up any of those picture frames before?

A: No.

Q: How did you fight Gary when he had a picture frame to your neck?

A: I pushed his hand. I asked him to take the frame out of his hand. I took the frame out of his hand and put it on the table. He picked up the frame again.

Q: Which hand did you use to take the frame with?

A: I don't remember. You have everything guys, just check.

Q: What hand did you push Gary with when he had the picture frame in his hand?

A: Right hand, I think.

Q: Did you see Gary grab the knife as you went upstairs?

A: No.

Q: Has Gary ever touched that knife before?

A: No. He never touched anything in my house except for the forks and cups.

Q: What does the knife look like?

A: The one I cut with tomatoes and onions.

Q: Can you describe what it looks like?

A: It has a black handle. It was big. You have it.

Q: Where was the knife before Gary picked it up?

A: It was in on the counter next to my sink.

Q: When you entered your room, how much time passed before you noticed Gary was standing in your room?

A: Right away. If Gary was far, I would have locked my room.

Q: Where was he standing when he entered your room and you noticed him?

A: He was standing at the entrance of my room.

Q: Did you scream?

A: I can't cause my kids were asleep.

Q: Which hand did you see the knife in?

A: In was in his right hand.

Q: What did Gary do with the knife?

A: He scared me with it.

Q: How did he scare you with it?

A: He showed me the knife and told me, "If you don't do what I want you to do, this knife will be in your body."

Q: How were your clothes removed?

A: Before he threw the knife on the ground, he asked me to kiss him and I kissed him back and he said okay take off your clothes. He took my pants off and said. He pulled my pants down with his hand and was touching me around my groin area. He then said, "know take it all off"

Q: Did he insert his fingers in to your vagina?

A: He grabbed my feet first and put his thing inside.

Q: What thing?

A: His penis.

Q: Did he use his fingers?

A: When I started crying he laid down next to me and told me to kiss it. Then he smacked me after I told him no.

Q: How did you get onto your bed?

A: He pushed me.

Q: What position did Gary have sex with you?

A: He was on top of me.

Q: Where did you place your hands?

A: It was on the bed.

CONTINUED:

Q: Did Gary touch any part of your body?

A: Breasts and I took his hands off.

Q: Did Gary remove his clothing?

A: No.

Q: What did he remove?

A: Just his t-shirt. He moved his pants down to his boots.

Q: What did he do with the knife?

A: I didn't see what he did with the knife until he finished.

Q: Was the knife washed before I collected them?

A: Yes.

Q: Did Gary ejaculate?

A: Yes.

Q: Where?

A: Before he came, he pushed up and said, "I'm not going come inside you to leave anything behind". He cleaned himself. He cleaned me and himself. He said, "nothing affects me, you don't have nothing."

Q: Was that when he threw the pants in your face?

A: Yes.

Q: Where was the pajamas located?

A: Everything was there, I don't know.

Q: Where did they land after they hit you?

A: I held it and started to cry.

Q: Did the pajamas touch anything in your room?

A: Bed Sheets.

Q: Did you wash those pajamas before I collected them?

A: No, I gave it to you.

Q: Did you wash your bed sheets before I collected them?

A: No.

Q: What did you do with the knife after you found it on the floor?

A: I take it downstairs and put it back with the knives.

Q: Were your children awake when you or Gary went downstairs afterwards?

A: No.

Q: Did you call anybody afterwards?

A: No, just my husband.

Q: What did you do after Gary left?

A: I took a shower and prayed, and talked to my husband.

Q: Did you see anybody or talk to anybody on Thursday night?

A: I saw a neighbor but I didn't say what happened. She stayed with me and I made juice. I saw his wife.

Q: Which neighbors?

A: My kid's friends, her mother.

Q: Did you see Zahra Thursday night?

A: Yes, I don't remember.

Q: On Friday, what did you talk to Zahra about in the morning?

A: Just about how I was doing. I told her I was going to MWC. She said she was going to come at 1130 to my house.

Q: What did you go to the MWC for?
A: My teacher works at MWC. My teacher made some copies of a school book that I needed for class so I went to pick it up.
Q: At this point, did Gary have a key to your house (Friday)?
A: I never gave him the key. Friday night, Zahra said she went to my house and took my key to get in to get some clothes for my children. I asked for the key back but know I have some stuff missing (jewelry).
Q: How come you didn't file a police report?
A: It was yesterday when I found out everything was missing.
Q: On Saturday, did Zahra tell you where she wanted to go when she said she wanted to go out?
A: No. She then said she wanted to take me to the hospital.
Q: What time did you leave Fort Irwin with Zahra and Gary?
A: I didn't check the time.
Q: Why did you agree to go to the hospital in Barstow instead of being seen here on Fort Irwin?
A: It's not Barstow. It's the one in San Diego. I know before a lady who was sick and they didn't have the material to help here on Fort Irwin. I know they can do a lot in San Diego.
Q: Who was your babysitter?
A: She's not babysitting her name is Marty. I trust her with my kids.
Q: Why did Zahra tell you not to trust anyone at Olive Garden?
A: I don't know.
Q: Do you know who could have taken \$800 from your purse?
A: No.
Q: Did you have your purse on you when you passed out at the MWC?
A: Yes.
Q: Who returned your purse back to you?
A: The nurse.
Q: Why did Gary follow you home?
A: I don't know.
Q: Why did you park in the trailer lot?
A: Cause that day when he was following and I was scared and that was the only easy way to get into the house. Sometimes I park there because it easier and quicker to leave from there too.
Q: If you parked in the trailer lot, would any of your neighbors know you were home?
A: Yes. You can still see the car from the windows of the houses and also from the street. Why would I hide my car from people? If I wanted to hide my car, I would park it in the garage.
Q: When you came back from Chahit's house and saw Gary, who entered the house first?
A: He walked first and sat on the sofa. I put my purse into the closet into the pantry. I had the phone in my hand.
Q: What was Gary wearing during this incident?
A: He was wearing a white T-Shirt and jeans.
Q: Which knife did he grab from the kitchen?
A: The knife I gave you guys. Black handle, smaller than the one before.
Q: What hand did he have it in?
A: Right hand.
Q: Was the knife washed after this incident?
A: No, I just grabbed after the incident. When the MP's came, I picked up the knife with a napkin and put it on the top of the sink to show it to Chahit. When the MP's came and touched the knife.
Q: Who touched the knife?

A: There was a white guy and a black guy. One of them touched the knife.

Q: Did Gary call anybody during this incident in your house?

A: No.

Q: Can you identify BOUZIDI?

A: He is a guy who works with my husband. He was an E-4. I just know him and her wife. When she was pregnant, I just moved onto Fort Irwin. She came over to welcome us. When she had the baby, I went to her house to take care of her.

Q: What drama occurred with BOUZIDI?

A: BOUZIDI called me a bitch to her unit. When the BOUZIDI told me I was in trouble and my husband was in trouble because there was rumors around the unit that I had men around in the house. A: When pushed me onto the sofa and had the knife in his hand, he was on top of me and I grabbed his shirt from the front.

Q: What did Gary do when you grabbed his shirt?

A: He pushed me and went outside.

Q: Were you afforded the opportunity to review your statement prior to signing?

A: Yes.

Q: Do you have anything else to add to this statement?
