That this matter having come before the Court on Plaintiff's Motion for Possession Pending Judgment, and the Court being fully advised in the premises:

**IT IS HEREBY ORDERED :**

**IT IS HEREBY AGREED** by and between the parties, that Plaintiff provide Defendants with the manufacture invoices and/or receipts showing purchases made by Plaintiffs of the claimed property;

**IT IS FURTHER AGREED THAT** the receipts will contain manufacturer contact information and phone numbers to verify the legitimacy of the receipts and will be furnished within 48 hours of the January 14, 2008 hearing;


**IT IS FURTHER AGREED THAT** the Defendants shall verify the receipts with the alleged manufacturers and compare the receipts to the units of clothing currently in the possession of the Wayne County Sheriff's Department by virtue of an inspection to occur at the Sheriff's Administration Building or such other location agreed upon by the parties by February 13, 2008; further, such inspection shall be completed before February 20, 2008.

**IT IS FURTHER AGREED THAT** Plaintiff's counsel shall be allowed to attend the inspection conducted by the Wayne County Sheriff's Department at the mutually agreed upon location, but no other agent of the plaintiff or private citizen will be permitted to attend without court approval;

**IT IS FURTHER AGREED THAT** items verified by manufacturers as having been legitimately purchased by Plaintiff and matching the SKU or other identification number to items currently in the possession of the Wayne County Sheriff's Department will be kept separate from those unable to be verified; all items legitimately itemized will be tendered to Plaintiff on February 22, 2008.


IT IS FURTHER AGREED THAT the parties re-appear before this Honorable Court on February 22, 2008, during motion call for further proceedings.
