Ma'am,

Rowe was the one who told me not to say anything and said that he was "good friends with Col Smith" that Col Smith had a lot of connections in the Marine Corps, that his brother worked for the Commandant and his dad was a well respected retired MajGen. Also Col Smith's wife seemed to be friends with Suzanne. Rowe said if I spoke about Suzanne that he would do everything he could to discredit me. I don't believe that Colonel Smith had any involvement, I think Rowe was just saying that to intimidate me. Rowe told me that if Suzanne started making any accusations about him that I should let him know because then he would talk to his "resources" to discredit Suzanne.

Because of how fearful Rowe was of me talking about Suzanne and because Capt Agoulnik and his wife said they also thought Rowe was having sex with Suzanne, I believed that he was. To the best of my memory, Rowe never told me directly that he was having sex with Suzanne but I observed Suzanne aggressively pursue him when he was extremely drunk, the Agoulniks thought he was having sex with Suzanne, and Rowe was very aggressive and interested that I not bring up Suzanne in the investigations.

I did not tell him that I was sharing stuff about Suzanne. During the NCIS phone call he asked me to let him know if any investigators would come talk to him about Suzanne or anything, he said he wanted heads up if they were. I believe that will be on the NCIS transcript at the end of the phone call from January or February 2011.
