- 1. I am currently assigned as a Logistics Observer/Trainer with United States Joint Forces Command, Joint Warfighting Center, Joint Training Division. My current duties include providing recommendations and assisting Combatant Command and JTF Staffs in improving their procedures, processes, during exercises and prior to real world deployments. I ve served honorably in the United States Marine Corps for over 23 years. My personal awards and decorations include the Meritorious Service Medal; Navy/Marine Corps Commendation Medal w/Gold Star; Joint Service Achievement Medal; Navy/Marine Corps Achievement Medal w/Gold Star; and the Navy/Marine Corps Parachutist Insignia.
- 2. I have known Major Rowe both professionally and socially for 19 years, while we both served at Camp Lejeune, NC. Major Rowe served with 8th Marine Regiment and I served with 2D FSSG.
