

On or about Friday October 22, 2010, I received a citation for speeding on a highway north of LA. I was enroute to Santa Barbara. I was in that area because I was making my way to Santa Barbara for a bicycle race. I am unfamiliar with the area and was, at the time of the stop, following a vehicle ahead of me so I did not pay attention to my specific location. I did not know the city where I was stopped nor did I recall the freeway, though I believe it was I-5. When I received the citation I was driving a rental vehicle that I had rented in San Diego. I placed the citation in the glove compartment of the rental vehicle. I returned the rental vehicle on October 24, 2010 but forgot to remove the citation from the glove compartment box. When I returned home to Michigan, I realized that I did not have the citation. I did not recall the law enforcement agency that issued the citation and neither the city nor the county. Accordingly, I did not know whom to contact coordinate a hearing date.

I respectfully request leave of court to challenge the citation and to be granted a new hearing date. I have included a check for the amount of the violation as a bond and request a court date. 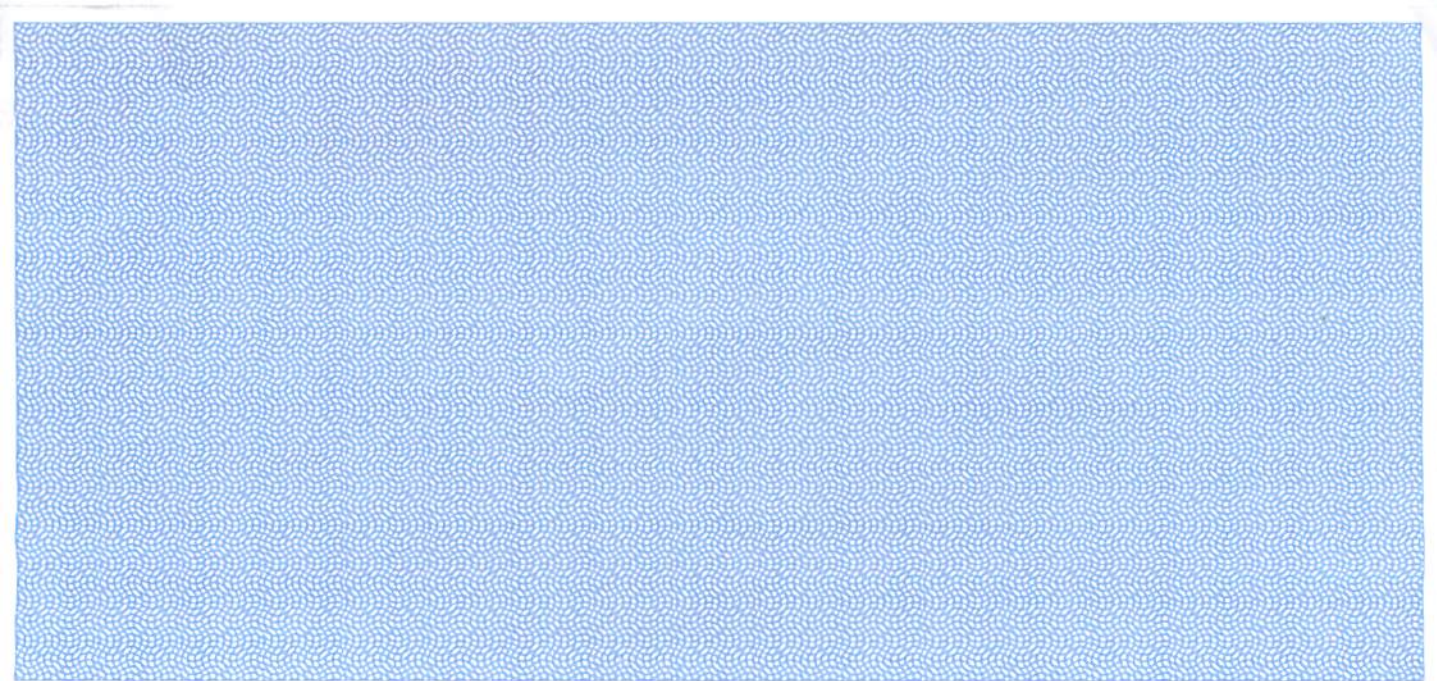

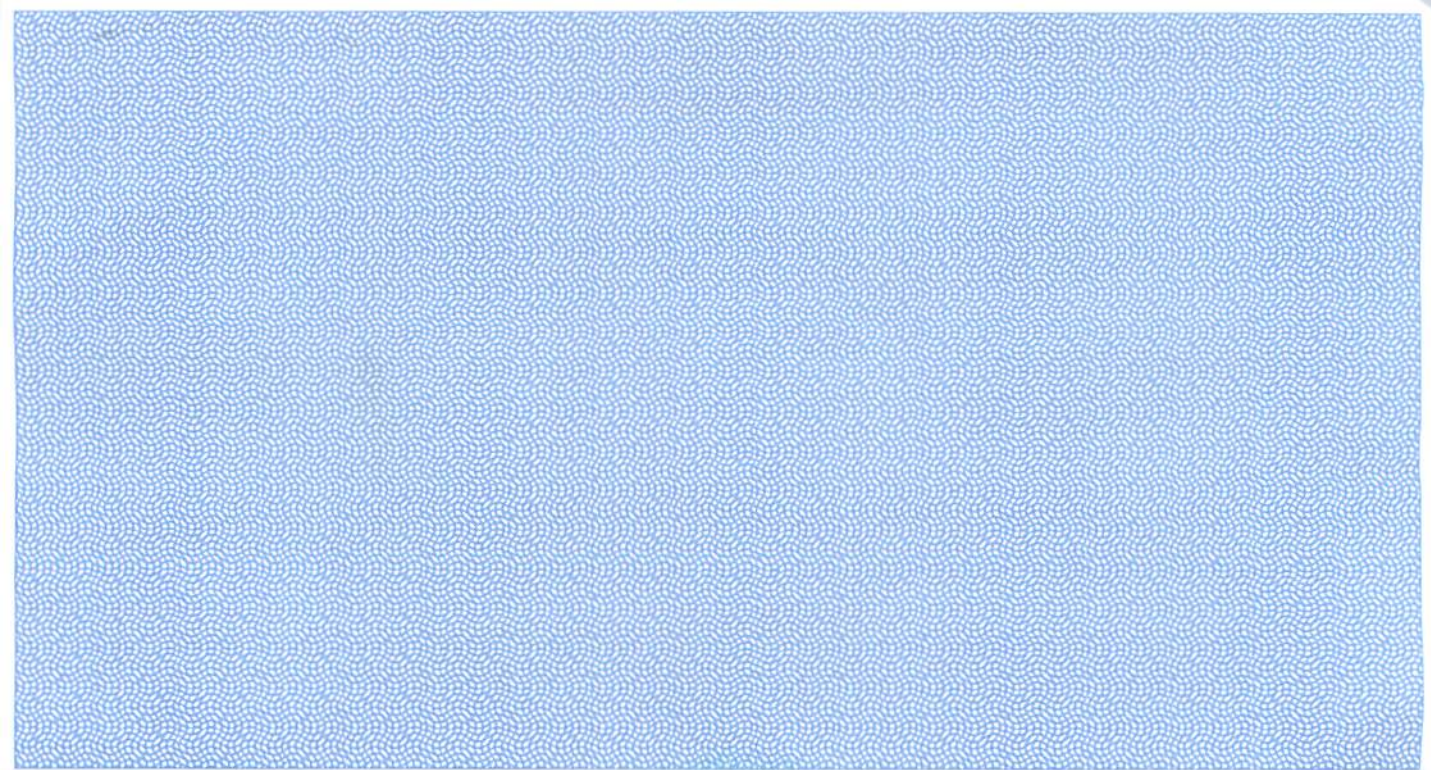
