9. MOHAMMED CHAHTI, WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH-

Yesterday around 2:00-2:30 PM, Hoda came over to my house and asked me to bring my Koran out to her car. I went out to the car and she asked me to swear on the Koran that I would not say anything, so I did. As soon as I finished swearing she started crying, telling me that she got raped by SPC Salah in the 58th Engineer Company, Fort Irwin. She said that he held a knife to her and made her get naked. I asked her to go talk to the MP's or the hospital, and she said that she was scared because he threatened to kill her, and nobody was going to believe her. I asked her to call SPC Salah and have him meet her with me there, to hear him admit to raping her. She told me that she couldn't do that because he would check the house before he said anything to her. I asked her to buzz my phone when he rang the doorbell and to leave the back door open or the garage door open so I could come over while he was there. She agreed to do that. She left to go back to her house and I went to the barber shop on post with my kids. I had just gotten to the barber shop and had pulled the numbers when she called me. She didn't buzz me she called and she was crying and screaming and I couldn't understand what she was saying. I left the PX and went to her house and the front door was open and I went inside. Hoda was on the kitchen couch crying and trying to show me where she had been grabbed on her shirt, she said that she had tried to stop him and kill him. After that I called the MP's and then I called Salah and asked him what he had done to Hoda, he said that he didn't do anything to her and he had tried to help her and she had tried to stab and kill him and that she didn't want him with his wife. I got off the phone with him and the MP's arrived. SPC Salah's wife was in the door to her house across the street and asked called me to come over and asked me what was going on so I told her what her husband was involved in and what Hoda was claiming had happened, she began to hit herself until the MP's came over and cuffed her.

A: I saw a red mark on her chest. She showed me that she had red marks on her wrist where she had tried to kill herself and that's why she had gone to the emergency room previously.

Q: Do you know when she went to the emergency room?

A: Friday the 20th of August.

Q: Did Hoda give you anymore details about being raped?

A: The only thing she told me is that he waited for her kids to be asleep, other than that she did not tell me any details.

Q: Did Hoda call SPC Salah to come over that day?

A: Yes.

Q: Do you know what was said between them?

A: Yes. I was sitting next to her when she called him. She told him that she needed him in her house in 20 minutes.

Q: What was SPC Salah and Hoda's relationship?

A: Friends and neighbors.

Q: Did Hoda say when the rape took place?

A: She wasn't sure and that it was 4 or 5 days ago.

Q: Where does SPC Salah live?

A: I don't know the address but it's across the street from where Salah lives.

Q: Do you know why Salah would come to you with this information?

A: She said that she trusted me.

Q: Did Hoda give you any details about her trying to kill him?

A: No.

Q: Did Hoda give you any more details about Salah threatening to kill her?

A: No.

Q: Do you have anything else to add to this statement?
