## DEFENDANT'S EMERGENCY MOTION FOR A PROTECTIVE ORDER OF DEFENDANT'S EMAIL ACCOUNTS PENDING DECISION BY THIS COURT ON DEFENDANT'S MOTION TO QUASH SUBPOENAS

Defendant, Issam Hamama, by and through undersigned counsel, respectfully requests this court immediately issue a protective order for the contents of email account <u>Hamama\_sam@yahoo.com</u> and <u>ih749@hotmail.com</u> pursuant to F.R.Cr.P. 16(d)(1).

On December 1, 2010, Defendant filed a motion to quash a subpoena for the contents of the two email accounts listed above. *ECF Document 42*. Defendant also sent by facsimile notices of objection to disclosure of the contents of the email accounts to the respective Internet Service Providers, Yahoo! and MSN, along with courtesy copies of the motion and brief.

On December 7, 2010, Defendant noticed peculiar activity on one of his email accounts. Defendant now believes that the ISPs may be acting on the Government's subpoenas. If the ISPs produce the contents of the email accounts, the Defendant's motion would be rendered moot before this court has had an opportunity to decide the matter. Accordingly, Defendant requests that this court issue a protective order to prohibit the Government from obtaining the contents of the email accounts until this court has decided the matter. Alternatively, if the Government has
