I am trying to collect statements from some of the offered witnesses he did not consult.

Good Morning Sir,

If matters are not going to be looked into I would be interested in going to the DOD IG or a high level civilian entity that would have an interest in this matter and would investigate without bias, as I am increasingly interested in getting to the bottom of Suzanne's sex scandal and believe that there has to be proof out there despite no one wanting to obviously be implicated in these matters. I have been told by Colonel Minor (LtGen Flynn SJA) that the outcome will have no bearing on my future in the Marine Corps so I am doing this only as a matter of principle, knowing that she is going to continue to have sex with Married men in the Marine Corps, lie to remain in position and be a horrible influence and hurt others-such as Kerr and I, abuse her power, and rely on the one skill that enabled her to get in that position, her ability to manipulate others.

MSgt Hunter is a good guy but extremely loyal to Suzanne since she doesn't have him work many weekend or night events and lets him leave at 1400 to commute back to Quantico most days. Also, MSgt Hunter is very level headed, but I don't think he is the best judge of people. He always seemed to think Suzanne was great and told me when I got to the shop when he thought they might be replacing me with her, that Suzanne was the only person he would work for. He mostly turned a blind eye to anything she would do and Havens really liked her since there was no discipline in the shop and Marines could run wild. An example of this is the day I observed Cpl Havens chew me out and tell MSgt Hunter he would non rec him because MSgt was overweight and get away with it. I don't believe a Cpl telling a MSgt that or being disrespectful to an officer would have been tolerated anywhere else in the Marine Corps, but I don't blame Havens, I blame Suzanne for her complete lack of professionalism or leadership. Cpl Havens was a talented Marine that was allowed to do whatever he wanted in the shop (he had to be non recd for his weight bc of S-3). Drinking during the day was not only allowed, but Suzanne set the example by doing it herself. Usually it was in her office, the Marines joked about her huge liquor cabinet below her desk which was from alcohol that had been given to her in exchange for extra tickets officers did not rate. Suzanne went out of her way to give tickets to men she liked or people that would help keep her in position. Once again a demonstration of her abuse of power. Her discussion of sex in the office to include discussion of her implants, sex life, being a very sexual person, was only in front of those who she usually had some kind of dirt on but completely inappropriate and disgusting.

An additional indicator of the lack of judgment is Suzanne's decision to bring LCpl Laster into the protocol shop after interviewing him. LCpl Laster (called Laster the disaster by the Marines) has extensive personal and mental problems and is completely incompetent. When tasked to do a simple go from point A to point B job he gets lost and goes to point C with the wrong items. Laster is a nice kid who is a complete burden on the shop and added no value. MSgt Hunter has taken him under his wing, but Laster is a kid who discussed his grandfather sexually abusing him openly in the shop, cried frequently as an 0311 about his wife's physical and verbal abuse towards him, talked about literally groveling on his hands and knees because his wife made him beg her for forgiveness. I recommended that he leave protocol because of his incompetence, burden on the shop and complete lack of tact in front of high ranking officials, but was not allowed to make any decision or provide input unless it would allow Suzanne to do less work. He was very complimentary towards Suzanne and she decided he needed to stay. I spoke extensively to LtCol Henger about how I was an officer in the shop but could not actually provide any leadership because Suzanne did not like anyone

else to be in power. The Marines knew they could get away with anything because Suzanne came in late and hungover all the time.

When Suzanne was told by LtCol Henger I would be in the shop to help out with the problems in the shop she became very angry and resentful that she was going to get an officer and not a Sgt. She told him in front of me that she had no use for me and then afterwards told me that I would provide no value to the office. Later she seemed receptive to me when I would be nice to her and listen to her talk about her personal life, which started out with her internet dating, breast implants, and later became her affairs and rampant sex with other officers and SNCOs at the Barracks. It did not take long for me to observe it's impact on me and the shop, but I felt powerless to do anything about it and always hoped that Col Montanus would figure it out after he came.

My entire motivation to work hard at drill was hoping I could get out of the protocol shop because Col Smith denied my request to deploy to Afghanistan as part of a by name request from VADM Harward. I requested to leave the command on three different occasions prior to my slapping the Marine who had called me a slut which is what I got in trouble for. I knew that Suzanne was very manipulative and feared her reprisal on me so deploying seemed like the best solution. I also was upset at the reputation that I seemed to start having for hanging out with Suzanne since many knew of her "sexual transgressions." I enjoyed the subject matter of protocol and hoped to work for future high level officials in the D.C. area, many of whom Suzanne had helped out with tickets or slept with men in their offices. I did not feel like she was a woman I could afford to anger.

When I asked Capt Monaghan why him and others would do anything with Suzanne when they live in an urban setting with other options, he replied "give a guy 10 beers and throw some big fake boobs in their face, when it's the only option most guys will hook up with anything and Suzanne makes herself very available"

I apologize if any of this information is not helpful, I am primarily interested to ask if the Command does not want to do anything about her so I can move onto the next step. I have been threatened by other officers in the Command and who have left the Command about talking about Suzanne since they had personal involvement with her or their friends and Marines did, but know if I don't speak up about it no one else probably will.

Lt Klay,

You raise several issues, supplemented by factual allegations.

1. My job is to substantiate or declare that I cannot substantiate your allegations. It is recommended you save your energy and refrain from continuing to advocate your beliefs of what occurred; you have done so on multiple occasions and myself and Maj Barclay are investigating all of the allegations you have made. I have spent time on this email when I should have spent the time working on uncovering the facts.
2. What you really need to understand, and as I said the first time I met you, just because you say it is so, does not make it so. On the other hand, even if my ultimate report does not substantiate your allegations, it does not mean that they did not occur. It means I could not prove it. Please know and respect the difference. Please this paragraph again; I really need you to fully appreciate the situation.
3. You ask me about consideration, I assume it is consideration for your promotion and/or BOI. That is outside of my lane; it is up to you and your defense counsel, if applicable, to argue what the deciding authorities should consider with respect to your future. I cannot advise you with that regard.

Also a large part of this is I do want to be believed so if I can provide a witness or something that would further help any area that is difficult to prove I would like to help out. Here are some additional thoughts that I hope can help:

Is it misconduct that Capt Wilson threatened to apprehend me by a junior Marine that didn't even belong to him while he read me my rights for a sexual crime he did not have proof I committed? Did Capt Wilson confirm that he did initially ask me to go to his office at 0430 and gave no reason why and he is not in my chain of command?

What about that the majority of the Marines saying negative things belonged to Alpha company ie the Company Wilson was a part of (Bushong, Sheffel Summerton etc). Was 1stSgt Nash asked or can he be asked if he ever gave a brief to Alpha Company about not participating in gang bangs during late summer? A junior Marine that played soccer on the indoor team I played on told me that 1stSgt Nash gave Alpha Company a liberty brief about not participating in gang bangs and not talking bad about people which the Marines decided he was talking about me/the centerhouse accusation. I called 1stSgt Nash and he confirmed to me that he did give that brief to the Marines. 1stSgt Nash was one of the married people Suzanne might have slept with, I don't know that for a fact but they did hang out drinking together one on one and she seemed to like him as more than a friend.

Is it a consideration that 3 senior officers above me, Capt Lawrence, Capt Wilson, Major Jones, wanted me to be NJPd for adultery I did not commit? Is Capt Lawrence telling Capt Shields months after that "she knew for a fact" I slept with Bowman appropriate? Is saying that she knows for a fact to other Marines gossip or intentionally meaning to cause harm? Capt Lawrence told me that she did not believe that I did not have sex with Capt Bowman. I told her that I had never been attracted to black guys and she became even more sure that I did.

I applied to get my Masters in Social Work and wondered if it was right that I would be willing to help others but not myself and debated about reporting it. I spoke to Rowe 2-3 times in Nov/Dec and he said he was getting therapy and that his therapist told him he should have gotten out of the Marine Corps a long time ago. I felt bad for him and did not want to hurt his wife.

Around November or so Rowe PCSd to Oklahoma. I could still not stop thinking about the incident that happened in my home. During vacation in Europe I could not sleep and when I came back, told NCIS during a follow up phone call about who it was since I thought it might be more safe since Rowe had PCSd and because I felt like it was a daily burden that had messed me up psychologically despite my efforts to improve my life.

Sir/Ma'am,

I thought it might be easier for me to write these things since I tend to be verbose and emotional during interviews about this subject.

I believe there are many great people in the Marine Corps but that the system to address sexual harassment is broken.

I hope that this investigation is not just aimed at making an "appeal proof" investigation, but at addressing the issues that existed; that all people should be treated with dignity in and out of the workplace. The burden of proof for someone to prove that sexual harassment was happening is extremely difficult and makes the victim subject to great amounts of reprisal that often can't be controlled.

When I spoke to Narelle Helmer, currently a pharmaceutical sales rep who lives in Wilmington, NC, who had been an officer at the Barracks in 2006-2007, she told me that if I tried to report anyone people would "come out of the woodwork" to fabricate stories and destroy my character and life. (poc 202-701-9026). She told me that she remembers walking by Marines who would say sexual comments about her and that she became depressed after she was raped by a Marine Major and started taking antidepressants. She said there wasn't a day that went by that she wasn't part of discussions for having large amounts of sex with junior Marines. She said she felt so resented that she started dating and became engaged to one of the only people who was nice to her, a SSgt in the command. She was NJPd and separated from service for her relationship with the SSgt and told me that the treatment while she was there was "the worst experience of her life" and that she doesn't think that young women should have to be stationed there.

When I arrived at the Barracks Capt Hart Smith had told me rumors about Narelle Helmer having sex with all the marching Marines in the Barracks. It seemed mean and untrue. Narelle used to be a cheerleader at Colorado and was very pretty and smart, had a lot going for her, I had a hard time believing she would subject herself to those kinds of things. Capt Rowe told me that Jenn Ryu, a Captain who had been at the Barracks was having sex with all the Body Bearers and that they would see them going in and out of her house on 9th street. I don't believe that those things are true, I just know that is a common part of being a female officer at 8th and I, and I don't think that should be that way.

Capt Rowe said the former parade Adjutant before Bonner had had sex with Ryu immediately before her wedding and that they all thought she was a slut. I have seen Capt Stephanie Drake cry because males (officers and non) in the marching company were saying she should be fired like Capt Snyder was sent to TECOM for falling out of the inauguration. She passed out during a Tuesday parade practice and the males were all saying that she didn't belong there and that she was an embarrassment. I think Capt Drake is a great officer and a strong individual. Because her husband is also at the Barracks, she will not have or hasn't had the same type of difficulties.

I believe Capt Lisa Lawrence to be jealous of other females and is highly insecure after failing out of flight school and surviving her career through numerous Equal Opportunity complaints based off of race. I think EO complaints are warranted and maybe she was academically hazed for her race, if so that is wrong; however, I think her EO complaint for having been assigned duty twice in one month by Capt O'Donnell was bizarre and her threat to "give her Captain Bars" to General Conway because they wouldn't let her be a female adj during parades to be bizarre. She openly aired this threat to many people (including Agoulnik and others). I think she is a great marcher, but like Capt Wilson, a good recruiting tool probably at a distance, but bad for anyone who knows them.

I believe that the goals I will achieve after my time in the Service will prove that I support the service and only want to make it better. I made mistakes while I was at 8th and I, in retrospect I would have recorded Suzanne's conversations about her sex with Major Jones and others, and requested mast to the Commandant after LtCol Henger decided not to investigate

I agree Suzanne and have been disappointed to hear from various people at the Barracks that MSgt Hunter and yourself have relayed that I was fired and other information that is either not true or not appropriate to share. I do not know for a fact that you said those things, but yesterday when I spoke to MSgt Hunter he admitted he had been relaying that I was fired for a while now with the verbiage depicted below. I let him know that he did not know all the facts nor do the Marines involved and it is in their interest that they do not.

The protocol Marines were important to me and I do not think my texting them to see how they are doing (ie Sutton in the case of his leaving) or anything of that matter is inappropriate. I put a lot of work into that office and did nothing to do any of them wrong and still have not. I do not know what is going on in that office but have only asked that the lack of tact in addressing where I have gone cease.

"She PCAd to HQMC" or something of that nature would be much more appropriate than "She was fired because of officer misconduct and is no longer with us" is NOT appropriate nor is it accurate. I ask that you relay this to them and others as their OIC as well as not discuss me to others so I can move on and pick up my feet in my professional and personal life. I think you can tell I have gone through enough and don't need the additional slander coming from those who I thought were my support system.

I do not think it is appropriate to tell the Marines that they can not talk to me and hope you have not done that. I have not told them anything that they do not need to know nor have I discussed you at all with them as I do not think it would be appropriate either.

Good evening sir,

The "rumors" about both were known by all. Lieutenant Klay is the one who drew attention to the situation by actively going around talking to different officers and enlisted Marines. Captain Bowman let the situation take whatever course it was going to take and remained silent about the situation. He did never challenge the rumors to prove his innocence because until he was accused, there was no need to. Please do not attribute the spread of rumors to unfair treatment of the female lieutenant versus the male lieutenant. Lieutenant Klay's actions increased the level of visibility. If she would have done what Captain Bowman did, the same amount of attention would have been applied especially seeing how the command did not look into the situation.

My greatest concern is that this investigation will not look into the fact that Lt Klay was responsible for the alleged rumors getting out. If she was being discriminated against, it would have been evident early in the process. The command would have conducted an investigation immediately following Captain Wilson's bringing this to the command's attention. If the command would have found Lt Klay guilty and Lt Bowman innocent of inappropriate behavior, then she would have a valid case.

I think everyone is investing too much into Lt Klay's credibility for the sake of not appearing impartial in addressing the serious concerns and accusations made by Lt Klay. In doing so, no one is giving a fair assessment of the facts.
