*Re: Mohamed Ayoub; proposed conditions of release*

Dear Ms. Kolb,

I appreciate the time you took to listen to my proposal and considerations of it. As I have already explained, I intend to take a personal interest in the rehabilitation of Mr. Mohamed Ayoub and his brother. In seeking to rehabilitate the two and ensure that they do not violate again, I have come up with a number of conditions that I believe will achieve the objective of rehabilitation while ensuring the safety and security of the two boys and the larger community.

The conditions I have come up with are based on my extensive experience in training and leading young men in the U.S. Marine Corps over a twenty-two year career. I have found such techniques to be effective leadership and mentoring tools that cause young men to develop a sense of responsibility, integrity, commitment and discipline. To ensure that conditions are having the desired impact, I, as well as, Mr. Ayoub's uncle will closely monitor and mentor. I have explained to Mr. Ayoub that any intentional or material breach of the conditions will result in him being returned to the custody of the State for further proceedings and possibly placement. I hope that you will continue find the conditions satisfactory and that the families of the victims will also find them acceptable.

**Conditions**

1. Restriction to the home (house arrest)<sup>1</sup> with an hourly reporting requirement during the hours of darkness and all day on weekends and days off from work or school with the following exceptions:
  - a. School or tutoring.
  - b. Work.



<sup>1</sup> House arrest means that Mr. Ayoub may not loiter "hang out" outside the home and its immediate periphery. He may leave for authorized activities. He must promptly return and not delay en route to or from authorized activities.

- c. A bona fide school sponsored activity, except that no school activity will be permitted if it brings the co-defendants or victims into contact with either of the Ayoub brothers without prior permission from the court.
  - d. Counseling sessions
  - e. A sanctioned athletic or fitness activity. Merely attending sporting events is not an athletic or fitness activity.
2. Report whereabouts to adult mentor at the commencement and conclusion when engaging in any activity other than a prescheduled and pre-authorized activity.
  3. Engage in a community service activity for no less than 2 hours per week. One hour should be conducted at the Juvenile Detention Center, engaged in janitorial type work.
  4. Meet with a mentor, who will be assigned, on a weekly basis to provide a positive role model and to facilitate opportunities for Mr. Ayoub to freely discuss matters that affect his life and environment.
  5. Mr. Ayoub along with his mother and brother must agree to undergo counseling with a licensed practitioner.
  6. Agree to undergo a psychological evaluation.
  7. Periodic drug testing.
  8. No contact with co-defendants.
  9. No loitering.
  10. Progress and adherence to the conditions will be monitored and recorded. Reports will be provided to the Court or prosecutor upon request.
