Dear Mr. Kane,

I request that your office take immediate action in releasing the vehicles listed below. On January 26, 2011, Ellissa Exchange and Hassan Ayash Exchange Co. were designated as specially designated narcotics traffickers. Subsequently OFAC effected the seizure of numerous vehicles because dock receipts for those vehicles listed Ellissa as a consignee. In the mass seizure of vehicles, OFAC also seized vehicles that did not list Ellissa or any other SDNT as a consignee or agent for the transaction.


