MEMORANDUM FOR RECORD

SUBJECT: State of Mental Health of SGT Andrew M. Doyle 20/██████████-2655

1. I have clinically interviewed SGT Doyle. He is diagnosed with chronic and severe post traumatic stress disorder (PTSD), post concussion syndrome (mTBI), depression, and severe insomnia.
2. SGT Doyle is undergoing a medical board for PTSD and post concussion syndrome.
3. His mental and physical health conditions are manifested by emotional detachment, increased irritability, anger, poor judgment, poor impulse control, and poor concentration.
4. The onset of his symptoms occurred prior to his last deployment. The severity of his symptoms worsened during his last deployment.
5. It is reasonable to conclude that his mental and physical health conditions did negatively alter his behaviors at the time of the August 2008 incident.

I Kristopher Ryan Wilson WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH

On the evening of 5 Aug 2008 D Co was informed that there was going to be multiple attacks on the Jalrez COP Madden Shar and FOB Airborne Using ISR the 100 spotted multiple SUVs and Vans being loaded with explosives. The company was going to act on this information and exploit the cache site. At around 1735 L 4th Pl SPED with 1st Plt and elements of HQ's to exploit this site. We moved west down MSR Montana when at around 1749 L at grid VD 83360 10312, an SVBIED struck the 2nd vehicle in the order of movement. Inside the vehicle was SFC Wilson (Me the IC) PFC Haffner (Driver), PFC Steidle (Gunner), PFC Biting (FO), and SPC Peake (Dismount). The SVBIED which was a black SUV that NPS typically drives, was moving from West to East along MSR Montana. It had passed the first truck and looked like it was pulling off to the side of the road to let us pass. At the last minute, the driver of the SVBIED accelerated and hit the front of D42 on the driver's side. What was different about the whole thing was that there were two people in the SVBIED instead of just one. There was very little time to react. PFC Haffner did the right thing by reacting quickly and moving the truck so it would not get a direct hit from the SVBIED. Before impact, we were traveling at around 50 MPH, the SVBIED was moving around 30 to 35 MPH when it hit us. Both vehicles stopped immediately. With the combined speed of both trucks, the two PAX's in the SVBIED were dazed, so they were unable to detonate the VBIED. All of us were dazed for a few seconds. At this point I realized what had just happened. Yelling, I told everyone to clear out of the truck. As soon as we were dismounted, we started taking heavy small arms fire from a house about 100 meters to the North. SFC Moriarty ran up to the SVBIED and shot the two occupants in the head as they regained consciousness so that they couldn't detonate the truck. All of us returned fire and then moved back towards the convoy for cover. SPC Peake, PFC Steidle and I exited on the IC side of the truck. PFC Biting and PFC Haffner exited on the driver's side. When we started taking fire from the houses to the North, SPC Peake and PFC Steidle moved to cover only 10 meters away from D42 and the SVBIED. Small arms fire was all around, kicking up dirt. I then realized that PFC Steidle and SPC Peake were still next to the impact site. I yelled for them to get up and move towards the back of the convoy. The convoy backed away from the SVBIED. SFC Moriarty then told PFC Fox, his gunner, to fire 50 cal into the SVBIED. As he did this a propane tank that was in the front seat caught on fire. PFC Biting and PFC Haffner were behind a dirt mound behind D43 and covering to the north. PFC Haffner and PFC Biting were able to PID at least three enemy PAX's from their position and return fire, helping to guide our Machine Gun fire onto the enemy. Still under heavy enemy fire, PFC Haffner and PFC Biting continued laying down suppressive fire to the north onto enemy locations as PFC Biting tried to determine a grid location to the enemy shooters. PFC Haffner provided covering fire for PFC Biting as he worked up an indirect mission for the commander from his position on the ground. After PFC Biting had finished determining the grids to the enemy and relayed the information to the Commander, the call came over LMR to move the casualties back to the convoy. We then moved back to the rest of the convoy to start CASE VAC and recover D11 which took damage to the radiator in the fire fight. SFC Moriarty pulled PFC Biting and PFC Haffner out of D43 and started to push them to the back of the convoy. Loading everyone up in the trucks the CASE VAC moved back to FOB Airborne. Then the convoy bypassed the burning SVBIED and got stand off from it for an indirect fire mission. SFC Moriarty ran to the SVBIED to recover the disabled HMV/WV when the vehicle exploded at least three times sending huge amounts of shrapnel and vehicle parts in all directions hitting myself in the left arm. SGT Doyle was hit in the right elbow with shrapnel causing him to bleed all over his uniform sleeve and SFC Moriarty was hit in the right calf and right arm running from the explosion. Indirect fire was called onto enemy positions destroying them and breaking the contact then we pushed the convoy to COP Jalrez where we had the medic treat myself, SGT Doyle and SFC Moriarty for our Shrapnel wounds. After we bombed two more SVBIED's in the area, we recovered the sensitive items from our wrecked truck, we returned to FOB Airborne under the cover of darkness. When we reached FOB Airborne, the remainder of us who were wounded, including myself, SGT Doyle and SFC Moriarty were treated by CPT Dunlap for our wounds. Nothing follows.
