10. CHARGE I: VIOLATION OF THE UCMJ, ARTICLE 80

SPECIFICATION: In that Sergeant First Class (E-7) Richard W. Jenkins, U.S. Army, did, at or near FOB Salerno, Afghanistan, between on or about 1 July 2009 and 7 December 2009, attempt to wrongfully commit indecent conduct, to wit: viewing Specialist Alyssa Barnett urinating by approaching her on foot, after having been warned not to approach her given her condition.

CHARGE II: VIOLATION OF THE UCMJ, ARTICLE 89

SPECIFICATION: In that Sergeant First Class (E-7) Richard W. Jenkins, U.S. Army, did, at or near FOB Salerno, Afghanistan, on divers occasions, between on or about 24 July 2009 and 7 December 2009, behave himself with disrespect toward First Lieutenant Petrina Chow, his superior commissioned officer, then known by the said Sergeant First Class Jenkins to be his superior commissioned officer, by saying to her "I want to touch your stuff;" "I want all of you but you won't even give me some of you;" "When you have an orgasm, do you scream as loud as when I tickle you;" "I want to make love to you;" "I want you to strip for me;" "you are a woman, I am a man, I am attracted to you;" "when you get all hot and bothered you can knock on my door and I will take care of you;" "Can you draw me in the nude, I want to see how you draw my 70's Afro-style pubic hair . . . are you au natural down there;" "We should engage in karma sutra . . . Obtaining sexual pleasure without actual penetration," "I want to give you a rub down later tonight . . . the code word is 'Romeo Bravo';" "I'm going to divorce my wife and marry you, because you are one hot Asian woman;" or words to that effect.

Jenkins, U.S. Army, did, at or near FOB Salerno, Afghanistan, on divers occasions between on or about 1 June 2009 and 8 December 2009, engage in sexual contact with Specialist Alyssa Barnett, to wit: thrusting his pelvis and groin area against Specialist Alyssa Barnett's legs and buttocks, and such sexual contact was without legal justification or lawful authorization and without the permission of Specialist Alyssa Barnett.

SPECIFICATION 3: In that Sergeant First Class (E-7) Richard W. Jenkins, U.S. Army, did, at or near FOB Salerno, Afghanistan, on divers occasions between on or about 1 June 2009 and 8 December 2009, engage in sexual contact with Specialist Ashley Nakasone, to wit: thrusting his pelvis and groin area against Specialist Ashley Nakasone's legs and buttocks, and such sexual contact was without legal justification or lawful authorization and without the permission of Specialist Ashley Nakasone.

SPECIFICATION 4: In that Sergeant First Class (E-7) Richard W. Jenkins, U.S. Army, did, at or near FOB Salerno, Afghanistan, on divers occasions between on or about 1 June 2009 and 8 December 2009, engage in sexual contact with Specialist Alyssa Barnett, to wit: grabbing and hitting her buttocks with his hand, and such sexual contact was without legal justification or lawful authorization and without the permission of Specialist Alyssa Barnett.
