Re: FINAL case report in the matter of *U.S. v. SPC Adam C. Winfield, USA*

1. **Case number and client's full name:** ACW-66387/D-0003; Adam C. Winfield

4. **Current status for the case being reported on:** Case complete. All outstanding bills received and expenses tallied. Delay attributable to phone bill charges and documentation for expenses arriving well after the case was complete.
5. **All activities since last monthly report:** Mr. Montalvo made several trips to Joint Base Lewis-McChord to interview witnesses, litigate motions and finally, negotiate the most favorable outcome for any of the Stryker Brigade soldiers. Adam Winfield pled guilty on 5 August 2011 to use of an illegal drug and manslaughter for failing to stop the murder of an Afghan citizen by his then squad leader, SSG Calvin Gibbs. The military judge sentenced him to three years in prison. Winfield has been in pre-trial confinement and will serve a little over another year in prison to complete his sentence. His pre-trial agreement included his willingness to testify at SSG Gibbs' trial. SPC Winfield was vindicated in his allegation that SSG Gibbs required his soldiers to participate in premeditated murders. SSG Gibbs was sentenced in October to life in prison. Winfield was initially charged with premeditated murder but he maintained that he shot above the victim after SSG Gibbs threw a grenade, blowing off the victim's legs. We argued continuously over the last year to show Winfield's good faith attempt to stop the murderous rampage by asking his father via a Facebook posting to warn the Army. The Army failed to investigate when Winfield's father called to warn them. Mr. Montalvo's litigation skills and negotiation efforts on Winfield's behalf convinced the Army to reduce the charges based on the facts. The results in the court-martial continued the long tradition of Puckett & Faraj, PC in representing America's young men and women who face impossible circumstances in the global war on terror.
